

In Louisiana, juvenile sentencing practices can vary widely from parish to parish and are subject to change over time. The following report, issued quarterly, is designed to offer an up-to-date view of juvenile custody and supervision populations, both statewide and for five OJJ service areas. 
It is our hope that monitoring these reports will help stakeholders at every level follow trends, inform planning, and identify areas in need of further investigation. The following observations are provided as examples to stimulate stakeholders to examine the data themselves with an eye toward local needs and concerns:

- During the second quarter of 2016 there were 505 youth served in a secure custody legal status, 275 non-secure custody, and 57 FINS custody statewide.
- Statewide, about 1.03 youth per thousand had a secure delinquent status; less than 0.56 per thousand had a non-secure delinquent status.
- African American youth are disproportionately represented in every custody and supervision status.










CUSTODY TYPE BY % AFRICAN AMERICAN



CUSTODY TYPE, PROBATION, AND PAROLE RATES BY RACE




Current Quarter: Service Area Comparisons by Custody Type


SECURE DELINQUENT CUSTODY
