#### Findings (By Provision):

**115.311 (a)** Acadiana Center for Youth at St. Martinville Pre-Audit Questionnaire response: The agency has a written policy mandating zero tolerance toward all forms of sexual abuse and sexual harassment in facilities it operates directly or under contract. The facility has a policy outlining how it will implement the agency's approach to preventing, detecting, and responding to sexual abuse and sexual harassment. The policy includes definitions of prohibited behaviors regarding sexual abuse and sexual harassment. The policy includes sanctions for those found to have participated in prohibited behaviors. The policy includes a description of agency strategies and responses to reduce and prevent sexual abuse and sexual harassment of residents.

Louisiana Office of Juvenile Justice PREA Manual, 6th edition, dated 2023, page 6, section I, states the Office of Juvenile Justice is committed to complying with all provisions of the U.S. Department of Justice (DOJ) "Prison Rape Elimination Act" (PREA) by establishing zero tolerance toward all forms of sexual abuse and sexual harassment and provide for safe practices related to the prevention, detection, reduction, and punishment of all sexual assaults.

The policy outlines the agency's approach to preventing, detecting, and responding to such conduct. The policy, pages 46-49, Appendix A - Definitions, includes definitions of prohibited behaviors regarding sexual abuse and sexual harassment and sanctions for those found to have participated in prohibited behaviors. OJJ policies address prevention of sexual abuse and sexual harassment through appropriate hiring and staffing of facilities, the designation of an agency PREA Coordinator, the designation of facility PREA Compliance Managers, staff supervision, identifying opportunities to separate and monitor sexually aggressive youth and potential victims, housing assignments, criminal background checks, staff training, resident education, PREA posters and educational materials and creating facility cultures that discourage sexual aggression, abuse and harassment. The policies address detection of sexual abuse and sexual harassment through resident education, providing specific treatment for youth with disabilities, providing protections for viewing and searches, staff training, and intake screening for risk of sexual victimization and abusiveness. The policies address responding to sexual abuse and sexual harassment through increasing awareness of safe reporting mechanisms and available services to victims, continuing education of staff and youth, investigations, disciplinary sanctions for residents and staff, victim advocates, access to emergency medical treatment and crisis intervention services, sexual abuse incident reviews, data collection, and data review for corrective action.

**115.311 (b)** Acadiana Center for Youth at St. Martinville Pre-Audit Questionnaire response: The agency employs or designates an upper-level, agency-wide PREA Coordinator. The PREA Coordinator has sufficient time and authority to develop, implement, and oversee agency efforts to comply with the PREA standards at the facility. The position of the PREA Coordinator is in the agency's organizational structure as the PREA Coordinator.

Louisiana Office of Juvenile Justice PREA Manual, 6th edition, dated 2023, page 7,

section II A.1, states YS shall employ a PREA Coordinator who is responsible for developing, implementing, and overseeing PREA compliance Agency wide.

The PREA Coordinator confirmed she has sufficient time and authority to develop, implement, and oversee agency efforts to comply with the PREA standards. Interactions with PREA Compliance manager is accomplished through phone, email, Zoom and in person facility visits. Issues identified with complying with a PREA standard are addressed through corrective action as needed and a follow-up walk through is conducted to see if the facility is following through with the actions.

**115.311 (c)** Acadiana Center for Youth at St. Martinville Pre-Audit Questionnaire response: The facility has designated a PREA Compliance Manager. The PREA Compliance Manager has sufficient time and authority to coordinate the facility's efforts to comply with the PREA standards. The position of the PREA Compliance Manager is in the agency's organizational structure as Program Specialist.

Louisiana Office of Juvenile Justice PREA Manual, 6th edition, dated 2023, page 7, section II A.2, states each facility shall designate a PREA Compliance Manager who shall be responsible for coordinating the facility's PREA compliance efforts.

The PREA Compliance Manager confirmed she has sufficient time and authority to coordinate the facility's efforts to comply with the PREA standards. The facility's efforts to comply with the PREA standards are coordinated through attending weekly leadership meetings and monthly facility planning meetings and providing input as it relates to PREA issues, training, unannounced walkthroughs to check for compliance, planning sexual abuse response team meetings, and consulting with investigative services. If an issue with complying with a PREA standard is identified, a meeting is held with the facility director to work toward compliance.

#### **Conclusion:**

Based upon the review and analysis of the available evidence, the auditor has determined the agency and facility is fully compliant with this standard requiring a zero-tolerance policy toward sexual abuse and sexual harassment and the designation of a PREA Coordinator and PREA Compliance Manager. No corrective action is required.

**115.313 (a)** Acadiana Center for Youth at St. Martinville Pre-Audit Questionnaire response: Since the 2018 PREA audit:

The average daily number of residents: 15

The average daily number of residents on which the staffing plan was predicated: 15

Louisiana Office of Juvenile Justice PREA Manual, 6th edition, dated 2023, page 7, section II.B.1, states each facility shall develop, implement, and document a staffing plan that provides for adequate level of staffing, and where applicable, video monitoring, to protect youth against all forms of abuse. In calculating adequate staffing levels and determining the need for video monitoring, facilities shall take into consideration the following:

- Generally accepted juvenile detention and correctional secure residential practices;
- Any judicial findings of inadequacy;

- Any findings of inadequacy from Federal investigative agencies;
- Any findings of inadequacy from internal or external oversight bodies;
- All components of the facility's physical plant (including "blind spots" or areas where staff or youth may be isolated);
- The composition of the youth population;
- The number and placement of supervisory staff;
- Facility programs occurring on a particular shift;
- Any applicable State or local laws, regulations, or standards;
- The prevalence of substantiated and unsubstantiated incident of sexual abuse;
- Any other relevant factors.

The auditor reviewed the facility staffing plan and observed the staffing plan is fully inclusive of the standard provision requirements.

**115.313 (b)** Acadiana Center for Youth at St. Martinville Pre-Audit Questionnaire response: Each time the staffing plan is not complied with, the facility documents and justifies all deviations from the staffing plan.

Louisiana Office of Juvenile Justice PREA Manual, 6th edition, dated 2023, page 7, section II.B.2, states facilities shall comply with the staffing plan except during limited, discrete exigent circumstances and shall fully document deviations from the plan during such circumstances. Only Security Staff are applicable in the staff to youth ratios. Deviations from staffing plans shall be fully documented.

**115.313 (c)** Acadiana Center for Youth at St. Martinville Pre-Audit Questionnaire response: The facility is obligated by law, regulation, or judicial consent decree to maintain staffing ratios of a minimum of 1:8 during resident waking hours and 1:16 during resident sleeping hours. The facility does not maintain staff ratios of a minimum of 1:8 during resident waking hours. The facility maintains staff ratios of a minimum of 1:16 during resident sleeping hours.

#### In the past 12 months:

Louisiana Office of Juvenile Justice PREA Manual, 6th edition, dated 2023, page 7, section II.B.3, states at least once per year, the agency in consultation with the PREA coordinator, shall assess, determine and document whether adjustments are necessary to the staffing plans and deployment of video monitoring and other monitoring systems for its secure care facilities. Upon completion of the Staffing Plan and attainment of all secure facility signatures, a copy shall be sent to the CO PREA Coordinator.

Steps taken to address any identified necessary adjustment to staffing patterns and deployment of monitoring systems shall be documented by the PREA Coordinator and affected facility PREA Compliance Manager for review by the U.S. DOJ.

Acadiana Center for Youth at St. Martinville is new facility as of September 2023. The staffing plan is dated December 14, 2023. There have been no staffing plan reviews.

**115.313 (e)** Acadiana Center for Youth at St. Martinville Pre-Audit Questionnaire response: The facility requires that intermediate-level or higher-level staff conduct unannounced rounds to identify and deter staff sexual abuse and sexual harassment. The facility documents unannounced rounds. The unannounced rounds cover all shifts. The facility prohibits staff from alerting other staff of the conduct of such rounds.

Louisiana Office of Juvenile Justice PREA Manual, 6th edition, dated 2023, pages 7-8, section II.C.1-2, states YS Policy and facility Standard Operating Procedures (SOPs) shall implement practices requiring intermediate or higher level supervisors to conduct and document unannounced rounds on all shifts to identify and deter sexual abuse and sexual harassment, pursuant to YS Policy No. C.2.19. Documentation of all unannounced rounds by supervisors shall be documented on the Supervisory Monitoring Log.

YS Policy and Facility SOPs shall prohibit staff from alerting other staff of the occurrence of supervisory rounds unless it is related to legitimate operational functions. Any unusual events or observations made during the performance of an unannounced round must be documented on an Unusual Occurrence Report as indicated in YS Policy No. A.1.14 "Unusual Occurrence Report".

An interview with the Assistant Director confirmed she conducts unannounced rounds. The rounds are conducted on all shifts and she stated she conducts the rounds are at different times. She documents the rounds on the Supervisory Monitoring Form.

The auditor reviewed documentation for the 12-month audit period, showing that unannounced rounds are occurring as required by policy. The facility records the unannounced rounds on the Supervisory Monitoring Form.

**Conclusion:** Based upon the review and analysis of the available evidence, the auditor has determined the facility is fully compliant with this standard regarding

#### Findings (By Provision):

**115.315 (a)** Acadiana Center for Youth at St. Martinville Pre-Audit Questionnaire response: The facility does not conduct cross-gender strip or cross-gender visual body cavity searches of residents.

In the past 12 months:

The number of cross-gender strip or cross-gender visual body cavity searches of residents: 0

The number of cross-gender strip or cross-gender visual body cavity searches of residents that did not involve exigent circumstances or were performed by non-medical staff: N/A

Louisiana Office of Juvenile Justice PREA Manual, 6th edition, dated 2023, page 8, section II.D.1, states cross-gender strip searches or visual body cavity searches are prohibited except in exigent circumstances or when performed by medical practitioners.

#### PREA Site Review:

The auditor reviewed the area where searches are performed and observed full searches would be conducted by female staff or staff of the resident's preference for transgender or intersex residents, not in view of staff of the opposite gender.

**115.315 (b)** Acadiana Center for Youth at St. Martinville Pre-Audit Questionnaire response: The facility does not permit cross-gender pat-down searches of residents, absent exigent circumstances.

#### In the past 12 months:

The number of cross-gender pat-down searches of residents that did not involve exigent circumstance(s): N/A

Louisiana Office of Juvenile Justice PREA Manual, 6th edition, dated 2023, page 8, section II.D.2, states cross-gender pat-down searches are prohibited unless exigent circumstances are present and shall be justified and documented on a UOR when they occur.

Residents interviewed confirmed no staff of the opposite gender have performed a pat-down search of their body. Staff interviewed confirmed they are restricted from conducting cross-gender pat-down searches. No staff interviewed provided an example of a circumstance that would warrant such a search other than searches of transgender or intersex residents.

**115.315 (c)** Acadiana Center for Youth at St. Martinville Pre-Audit Questionnaire response: Facility policy requires that all cross-gender strip searches, cross-gender visual body cavity searches, and cross- gender pat-down searches be documented and justified.

Louisiana Office of Juvenile Justice PREA Manual, 6th edition, dated 2023, page 8, section II.D.1, states pursuant to YS Policy Nos. B.2.20 and C.2.3, when cross-gender searches occur they must be justified and documented on an Unusual Occurrence Report (UOR) by the employee conducting the search and a witness to the search.

**115.315 (d)** Acadiana Center for Youth at St. Martinville Pre-Audit Questionnaire response: The facility has implemented policies and procedures that enable residents to shower, perform bodily functions, and change clothing without non-medical staff of the opposite gender viewing their breasts, buttocks, or genitalia, except in exigent circumstances or when such viewing is incidental to routine cell checks (this includes viewing via video camera). Policies and procedures require staff of the opposite gender to announce their presence when entering a resident housing unit or area where residents are likely to be showering, performing bodily functions, or changing clothing.

Louisiana Office of Juvenile Justice PREA Manual, 6th edition, dated 2023, page 8, section II.D.3-4, states YS policies and secure care facility SOPs shall be implemented that enable youths to shower, perform bodily functions, and change clothing without nonmedical staff of the opposite gender viewing private body parts

except in exigent circumstances or when such viewing is incidental to routine cell checks.

YS policies, facility SOPs and contract facility SOPs shall provide procedures for cross-gender staff announcing their entrance into housing areas

Staff interviews confirmed male staff would announce their presence if they were to enter one of the housing units. They also confirmed residents are able to shower, change clothing, and perform bodily functions without being seen by male staff. Resident interviews confirmed female staff announce their presence if they enter one of the housing units. No residents interviewed reported ever having been naked in full view of female staff while showering, changing clothing, or performing bodily functions.

#### PREA Site Review:

Residents are able to shower and change clothing in the privacy of an individual shower stall behind a curtain. Toilets and sinks are located in the cells. The auditor observed cross-gender announcements during the site review. The auditor observed no bathrooms or showers are in camera view.

**115.315 (e)** Acadiana Center for Youth at St. Martinville Pre-Audit Questionnaire response: The facility has a policy prohibiting staff from searching or physically examining a transgender or intersex resident for the sole purpose of determining the resident's genital status. Zero (0) such searches occurred in the past 12 months.

Louisiana Office of Juvenile Justice PREA Manual, 6th edition, dated 2023, page 8, section II.D.5, states searches, or physical exams of transgender or intersex youth shall not be utilized solely to determine genital status. Alternative methods of determining status if necessary, shall be utilized.

Staff interviews confirmed they are aware policy prohibits them from conducting a physical examination or search of transgender or intersex resident solely for the purpose of determining the resident's genital status.

The auditor interviewed one resident who identified as transgender. The resident stated he had no searches preference. He stated the initial search was a full search and he did not believe this was done to determine his gender.

**115.315 (f)** Acadiana Center for Youth at St. Martinville Pre-Audit Questionnaire response: The percent of all security staff who received training on conducting cross-gender pat-down searches and searches of transgender and intersex residents in a professional and respectful manner, consistent with security needs: 100%

Louisiana Office of Juvenile Justice PREA Manual, 6th edition, dated 2023, page 8, section II.D.5, states staff shall be appropriately trained on conducting cross-gender pat-down searches, and searches of transgender and intersex youth pursuant to YS Policy Nos. A.2.24 and B.2.20.

Staff interviewed confirmed they have received training on how to conduct crossgender pat down searches and searches of transgender residents in a professional and respectful manner, consistent with security needs. Training is accomplished using the Guidance in Cross-Gender and Transgender Pat Searches Training Curriculum and video.

The auditor reviewed the Guidance in Cross-Gender and Transgender Pat Searches Training Curriculum and video. The auditor observed the facility uploaded training attendance rosters for gender responsive training to the online audit system for the standard provision. The PREA Compliance Manager emailed clarification on April 29, 2024, that the gender responsive training attendance rosters were uploaded in error. The facility provided a statement on May 3, 2024 specifying the training conducted in 2023 included training on how to conduct cross-gender pat down searches and searches of transgender residents. The auditor reviewed 2023 Staff Confirmation of Receipts of PREA and Letters of Attestation for PREA Training for contracted medical and mental health staff for verification training on how to conduct cross-gender pat down searches and searches of transgender residents was provided. The auditor observed the training was received by 16 staff and contractors.

**Conclusion:** Based upon the review and analysis of the available evidence, the auditor has determined the facility is compliant with this standard regarding limits to cross-gender viewing and searches. No corrective action is required.

#### **Findings (By Provision):**

**115.316 (a)** Acadiana Center for Youth at St. Martinville Pre-Audit Questionnaire response: The agency has established procedures to provide disabled residents equal opportunity to participate in or benefit from all aspects of the agency's efforts to prevent, detect, and respond to sexual abuse and sexual harassment.

Louisiana Office of Juvenile Justice PREA Manual, 6th edition, dated 2023, page 9, section II.E.1-4, states youth with disabilities shall have an equal opportunity to participate in and benefit from all aspects of YS's efforts to prevent, detect, and respond to sexual abuse and sexual harassment. When necessary, to ensure effective communication, youth with hearing deficits shall be provided an interpreter. Written materials shall be provided in a format which ensures effective communication with youth with disabilities. YS is not mandated to take steps which would result in a fundamental alteration in a service program or activity or in undue financial and administrative burdens in accordance with Title II of the American with Disabilities Act (ADA).

The Deputy Secretary confirmed services are in place to provide residents who are deaf or hard of hearing or residents with disabilities equal opportunity to participate in or benefit from all aspects of the agency's efforts to prevent, detect, and respond to sexual abuse and sexual harassment.

The auditor observed the facility has translation services available through a contract with 1-World Language LLC. PREA materials would be available in Braille and other formats through the contract with the Louisiana Special School District. Special education teachers and mental health staff are available as needed.

No residents with a cognitive or functional disability were identified during the onsite phase of the audit.

The auditor reviewed 2023 Staff Confirmation of Receipts of PREA and Letters of Attestation for PREA Training for contracted medical and mental health staff for verification staff training on PREA compliant practices for residents with disabilities was provided. The auditor observed the training was received by 16 staff and contractors. The facility provided a statement on May 3, 2024, specifying that the training included PREA compliant practices for residents with disabilities.

**115.316 (b)** Acadiana Center for Youth at St. Martinville Pre-Audit Questionnaire response: The agency has established procedures to provide residents with limited English proficiency equal opportunity to participate in or benefit from all aspects of the agency's efforts to prevent, detect, and respond to sexual abuse and sexual harassment.

Louisiana Office of Juvenile Justice PREA Manual, 6th edition, dated 2023, page 9, section II.E.1, states youth who are limited English proficient shall have meaningful access to all aspects of YS' efforts to prevent, detect, and respond to sexual abuse and sexual harassment.

The auditor observed 1-World Language LLC provides interpreter services for limited English proficient residents. The Youth PREA Orientation is available in English and Spanish. The Youth Safety Guide Pamphlet is also available in English and Spanish.

There were no residents who are limited English proficient identified during the onsite phase of the audit. The auditor was able to test the availability of language translation through information provided by the agency. During the mock intake, the Social Services Supervisor contacted the interpreter service through instructions provided by Louisiana Office of Juvenile Justice Policy, B.8.5: Language Assistance Services dated May 4, 2023.

The auditor reviewed 2023 Staff Confirmation of Receipts of PREA and Letters of Attestation for PREA Training for contracted medical and mental health staff for verification staff training on PREA compliant practices for residents with Limited English Proficiency was provided. The auditor observed the training was received by 16 staff and contractors. The facility provided a statement on May 3, 2024, specifying the training included PREA compliant practices for residents with Limited English Proficiency.

**115.316 (c)** Acadiana Center for Youth at St. Martinville Pre-Audit Questionnaire response: Agency policy prohibits use of resident interpreters, resident readers, or other types of resident assistants except in limited circumstances where an extended delay in obtaining an effective interpreter could compromise the resident's safety, the performance of first-response duties under § 115.364, or the investigation of the resident's allegations. The agency or facility documents the limited circumstances in individual cases where resident interpreters, readers, or other types of resident assistants are used.

In the past 12 months, the number of instances where resident interpreters, readers, or other types of resident assistants have been used and it was not the case that an extended delay in obtaining another interpreter could compromise the resident's safety, the performance of first-response duties under § 115.364, or the investigation of the resident's allegations: 0

Louisiana Office of Juvenile Justice PREA Manual, 6th edition, dated 2023, page 9, section II.E.2, states youth interpreters, readers or assistants shall not be relied upon except where an extended delay in obtaining an effective interpreter could compromise a youth's safety, the performance of first-responder duties under US

DOJ PREA Standard 115.364, or the investigation of the youth's allegations. Translation services will be provided through outside contractors and resources.

There were no residents in need of an interpreter during the onsite phase of the audit.

Staff interviews confirmed no resident interpreters, resident readers, or other types of resident assistants have been used in been used in relation to allegations of sexual abuse or sexual harassment in the 12 months preceding the audit.

**Conclusion:** Based upon the review and analysis of the available evidence, the auditor has determined the facility is fully compliant with this standard regarding residents with disabilities and residents who are limited English Proficient. No corrective action is required.

- **115.317** (a) Acadiana Center for Youth at St. Martinville Pre-Audit Questionnaire response: Agency policy prohibits hiring or promoting anyone who may have contact with residents, and prohibits enlisting the services of any contractor who may have contact with residents, who:
- 1. Has engaged in sexual abuse in a prison, jail, lockup, community confinement facility, juvenile facility, or other institution (as defined in 42 U.S.C. 1997);
- 2. Has been convicted of engaging or attempting to engage in sexual activity in the community facilitated by force, overt or implied threats of force, or coercion, or if the victim did not consent or was unable to consent or refuse; or
- 3. Has been civilly or administratively adjudicated to have engaged in the activity described in paragraph (a)(2) of this section.

Louisiana Office of Juvenile Justice PREA Manual, 6th edition, dated 2023, page 9, section II.F.1.a-c, states job applicants and contractors shall NOT be hired, or services contracted for if the applicant/contractor has:

- Engaged in sexual abuse in a prison, jail, lockup, community confinement facility or juvenile facility or other institution as defined in federal law. (42 USC 1997)
- Been convicted of engaging or attempting to engage in sexual activity in the community using force, overt or implied threats of force, or coercion, or if the victim did not consent or was unable to consent or refuse; or
- Been civilly or administratively adjudicated to have engaged in any activity described in subparagraph b. above.

The HR staff interview revealed the facility will ask all applicants and employees about previous misconduct in written applications for hiring and promotions and in written self-evaluations conducted as part of reviews for current employees.

The auditor reviewed 12 PREA Questionnaires for new staff and contractors and observed new staff hires asked and answered the 3 questions regarding past conduct.

The auditor requested the PREA Questionnaires for new staff and contractors for contractors interviewed to enable a compliance determination with the standard provision. The agency provided the documentation June 18, 2024. The auditor reviewed the documents and observed contractors asked and answered the 3 questions regarding past conduct.

**115.317 (b)** Acadiana Center for Youth at St. Martinville Pre-Audit Questionnaire response: Agency policy requires the consideration of any incidents of sexual harassment in determining whether to hire or promote anyone, or to enlist the services of any contractor, who may have contact with residents.

Louisiana Office of Juvenile Justice PREA Manual, 6th edition, dated 2023, page 10, section II.F.3.d, states the agency shall consider any incidents of sexual harassment in determining whether to hire anyone, or to enlist the services of any contractor, who may have contact with inmates. The agency shall ask all applicants and employees who may have contact with inmates directly about previous misconduct described above in written applications or interviews for hiring. (28 CFR § 115.17)

The HR staff stated the department considers prior incidents of sexual harassment in determining whether to hire or promote anyone, or to enlist the services of any contractor, who may have contact with the residents.

The auditor observed the agency updated the PREA Questionnaire for new staff and contractors January 25, 2023, to include consideration of incidents of sexual harassment. The auditor reviewed 13 PREA Questionnaires for new staff and contractors for staff and observed incidents of sexual harassment were considered.

The auditor requested the PREA Questionnaire for new staff and contractors for contracted staff interviewed to enable a compliance determination with the standard provision requirement of considering any incidents of sexual harassment in determining whether to enlist the services of any contractor, who may have contact with residents. The agency provided the documentation June 18, 2024. The auditor reviewed the documents and observed incidents of sexual harassment are considered when enlisting the services of a contractor.

**115.317 (c)** Acadiana Center for Youth at St. Martinville Pre-Audit Questionnaire response: Agency policy requires that before it hires any new employees who may have contact with residents, it (a) conducts criminal background record checks, (b) consults any child abuse registry maintained by the State or locality in which the employee would work; and (c) consistent with Federal, State, and local law, makes its best efforts to contact all prior institutional employers for information on substantiated allegations of sexual abuse or any resignation during a pending investigation of an allegation of sexual abuse.

- a. The Unit's HR Liaison shall perform a criminal background check pursuant to YS Policy No. A.2.18;
- b. DPS HR will send a list of newly hired OJJ employees to DCFS on the first and the fifteenth of each month for the purpose of conducting Child Abuse Registry checks. Should the designated date fall on a non-working day, the list will be sent on the closest regularly scheduled work day immediately preceding the designated send date. In the event a violation OJJ will be immediately notified, otherwise a quarterly review of submissions will be sent to the Undersecretary, Deputy Undersecretary or designee(s) of the results for record keeping and auditing purposes.

Notification of hire must be received in HR no later than 12pm on the last working day prior to the list being sent to DCFS for screening. Should notification be received in HR of a pending new hire after this deadline, or the number of allowable submissions to DCFS have been exceeded, that applicant will be added to a future

submission; and

c. Consistent with law, PSS/HR shall additionally use their best efforts to contact all prior institutional employers for information on substantiated allegations of sexual abuse or resignation during a pending investigation of allegation of sexual abuse. (28 CFR § 115.17)

The HR staff confirmed the department performs criminal background record checks and considers pertinent civil or administrative adjudications for all newly hired employees who may have contact with the residents and all employees, who may have contact with residents who are being considered for promotions. The HR staff also confirmed the agency consults the Louisiana Department of Children and Family Services State Central Registry.

The auditor reviewed 12 criminal record check requests for staff interviewed and observed the agency performs criminal background record checks in compliance with the standard provision requirements.

The auditor reviewed 16 Louisiana Department of Children and Family Services State Central Registry Disclosures for staff interviewed and observed the agency consults the child abuse registry maintained by the State of Louisiana in compliance with the standard provision requirements.

The auditor observed the Louisiana Office of Juvenile Justice PREA Reference Checks asks about previous work for institutional employers. The auditor reviewed 2 applicable examples and verified prior institutional employers are contacted in compliance with the standard provision requirement.

**115.317 (d)** Acadiana Center for Youth at St. Martinville Pre-Audit Questionnaire response: Agency policy requires that a criminal background records check be completed, and applicable child abuse registries consulted before enlisting the services of any contractor who may have contact with residents.

During the past 12 months:

The HR staff confirmed the facility makes its best effort to contact all prior institutional employers for information on substantiated allegations of sexual abuse or any resignation during a pending investigation of an allegation of sexual abuse.

The auditor requested the criminal record check requests for contracted staff interviewed to enable a compliance determination. Through corrective action, the facility provided the criminal record check requests June 18, 2024.

The auditor requested the Louisiana Department of Children and Family Services

State Central Registry Disclosures for contracted staff interviewed to enable a compliance determination. Through corrective action, the facility provided the DCFS State Central Registry Disclosures May 2, 2024.

**115.317 (e)** Acadiana Center for Youth at St. Martinville Pre-Audit Questionnaire response: Agency policy requires that either criminal background records checks be conducted at least every five years of current employees and contractors who may have contact with residents or that a system is in place for otherwise capturing such information for current employees.

The HR staff confirmed the Louisiana Office of Juvenile has in place a system that alerts agency staff of an arrest.

**115.317 (f)** Louisiana Office of Juvenile Justice PREA Manual, 6th edition, dated 2023, page 10, section II.F.4-5, states job applicants and employees shall be asked directly about previous misconduct described in Section II.F.1.a - c above in written applications, interviews for hiring or promotions, and in any interviews or written self-evaluations conducted as part of reviews of current employees.

Employees have a continuing duty to disclose any such misconduct; material omissions or providing materially false information shall be grounds for termination.

The HR staff interview revealed the facility will ask all applicants and employees about previous misconduct in written applications for hiring and promotions and in written self-evaluations conducted as part of reviews for current employees.

The auditor observed the PREA Questionnaire documents the 3 questions regarding past conduct. The PREA Questionnaires are asked used at hire, promotion, and in any interviews or written self-evaluations conducted as part of reviews of current employees. The auditor reviewed 13 PREA Questionnaire conducted as part of reviews of current employees in 2023. The agency reported there were no applicable promotions during the 12-month audit period.

**Conclusion and Corrective Action:** Based upon the review and analysis of the available evidence, the auditor has determined the facility is fully compliant with this standard regarding hiring and promotion decisions. Corrective action is complete.

The agency provided the documentation June 18, 2024. The auditor reviewed the documents and observed incidents of sexual harassment are considered when enlisting the services of a contractor.

- **115.317 (d)** The agency shall also perform a criminal background records check, and consult applicable child abuse registries, before enlisting the services of any contractor who may have contact with residents.

**115.318** (a) Acadiana Center for Youth at St. Martinsville Pre-Audit Questionnaire response: The agency or facility has acquired a new facility or made a substantial expansion or modification to existing facilities since the last PREA audit.

Louisiana Office of Juvenile Justice PREA Manual, 6th edition, dated 2023, page 11, section II.G.1, states all designing, acquiring, renovations, additions, and new construction shall be of a design that facilitates direct contact between youth and staff, while considering the agency's ability to protect youth from sexual abuse.

Acadiana Center for Youth at St. Martinsville is a new facility. The Deputy Secretary and Facility Director both confirmed the facility would consider the ability to protect residents from sexual abuse when designing or acquiring any new facility and in planning any substantial expansion or modification of existing facilities. Also, the agency would consider the effect of the design, acquisition, expansion, or modification upon the agency's ability to protect residents from sexual abuse.

**115.318 (b)** Acadiana Center for Youth at St. Martinsville Pre-Audit Questionnaire response: The agency or facility has not installed or updated a video monitoring system, electronic surveillance system, or other monitoring technology since the last PREA audit.

Louisiana Office of Juvenile Justice PREA Manual, 6th edition, dated 2023, page 11, section II.G.2, states when installing or updating a video monitoring system, electronic surveillance system, or other monitoring technology, the agency shall consider how such technology may enhance the agency's ability to protect youth from sexual abuse.

The Deputy Secretary and Facility Director both confirmed when installing or updating a video monitoring system, electronic surveillance system, or other monitoring technology, the agency shall consider how such technology may enhance the agency's ability to protect residents from sexual abuse.

**Conclusion:** Based upon the review and analysis of the available evidence, the auditor has determined the agency and facility is fully compliant with this standard regarding upgrades to facilities and technologies. No corrective action is required.

#### Findings (By Provision):

**115.321 (a)** Acadiana Center for Youth at St. Martinville Pre-Audit Questionnaire response: The facility is responsible for conducting administrative or criminal sexual abuse investigations (including resident-on- resident sexual abuse or staff sexual misconduct).

The Louisiana Office of Juvenile Justice Department of Investigative Services (IS) is responsible for administrative and criminal investigations of allegations of sexual abuse.

Staff interviews confirmed they are knowledgeable of the agency's protocol for obtaining usable physical evidence if a resident alleges sexual abuse. Staff were knowledgeable that the Louisiana Office of Juvenile Justice Department of Investigative Services (IS) is responsible for conducting sexual abuse investigations.

**115.321 (b)** Acadiana Center for Youth at St. Martinville Pre-Audit Questionnaire response: The protocol is developmentally appropriate for youth.

Louisiana Office of Juvenile Justice PREA Manual, 6th edition, dated 2023, page 11, section III.A.1-2, states investigative Services (IS) shall follow a uniform evidence protocol that maximizes the potential for obtaining usable physical evidence for administrative proceedings and criminal prosecutions, pursuant to YS Policy Nos. A.1.4 and C.4.6.

The protocol shall be developmentally appropriate for youth and as appropriate,

shall be adapted from or otherwise based on the most recent edition of the U.S. DOJ's Office on Violence Against Women publication, "A National Protocol for Sexual Assault Medical Forensic Examinations, Adults/Adolescents," or similarly comprehensive and authoritative protocols developed after 2011.

The PAQ indicates the protocol was adopted from the DOJ's Prison Rape Elimination Act of 2012 to establish procedures for implementing PREA in secure care facilities. The auditor reviewed the Acadiana Center for Youth at St. Martinville Sexual Abuse Protocol. The document details how the facility would respond to an incident of sexual abuse.

**115.321 (c)** Acadiana Center for Youth at St. Martinville Pre-Audit Questionnaire response: The facility offers all residents who experience sexual abuse access to forensic medical examinations. Forensic medical examinations are offered without financial cost to the victim. Where possible, examinations are conducted by Sexual Assault Forensic Examiners (SAFEs) or Sexual Assault Nurse Examiners (SANEs). When SANEs or SAFEs are not available, a qualified medical practitioner performs forensic medical examinations.

Louisiana Office of Juvenile Justice PREA Manual, 6th edition, dated 2023, pages 11-12, section III.B, states youth who experience sexual abuse shall have access to forensic medical examinations, without financial cost where evidentiary or medically appropriate. Such examinations shall be performed by Sexual Assault Forensic Examiners (SAFEs) or Sexual Assault Nurse Examiners (SANEs) where possible.

If SAFEs or SANEs cannot be made available, the examination can be performed by other qualified medical practitioners. The CHP shall document its efforts to provide SAFEs or SANEs and forward that documentation to the youth's Case Manager for entry into JETS.

Louisiana Laws Revised Statutes Title 13 - Courts and Judicial Procedure §13:5713. Duties; autopsies and investigations, states the coroner or his designee shall examine all alleged victims of a sexually-oriented criminal offense. The coroner may select the hospital or healthcare provider named as the lead entity for sexual assault examinations in the regional plan required by R.S.40:1216.1 as his designee to perform the forensic medical examination.

The auditor reviewed the Acadiana Center for Youth at St. Martinville Sexual Abuse Protocol dated August 2023, and observed the protocol designates Our Lady of Lourdes Women's & Children's Hospital as the hospital where resident victims of sexual abuse would receive care. Additionally, the RN confirmed resident victims of sexual abuse would have access to forensic medical examinations at Our Lady of Lourdes Women's & Children's Hospital and forensic medical examinations are provided at no cost to the victim.

**115.321 (d)** Acadiana Center for Youth at St. Martinville Pre-Audit Questionnaire response: The facility makes a victim advocate from a rape crisis center available to the victim, in person or by other means. These efforts are documented. If and when a rape crisis center is not available to provide victim advocate services, the facility provides a qualified staff member from a community-based organization or a qualified agency staff member.

Louisiana Office of Juvenile Justice PREA Manual, 6th edition, dated 2023, page 12, section III.C.1-2, states every attempt shall be made to make a victim advocate from a rape crisis center available to the victim. If a rape crisis center is not available to provide victim advocate services, a qualified staff member from a community-based organization or a qualified Agency staff member shall be made available to provide these services.

Efforts to secure services from rape crisis centers shall be documented by the CHP. A rape crisis center that is part of a governmental unit may be utilized as long as the center is not part of the criminal justice system (such as a law enforcement Agency) and offers a comparable level of confidentiality as a nongovernmental entity that provides similar victim services. Documented efforts shall be forwarded by the CHP to the youth's Case Manager for entry into JETS.

The PREA Compliance Manager confirmed the facility would make available to the victim a victim advocate and that a memorandum of understanding is in progress.

The auditor observed Acadiana Center for Youth at St. Martinville has an unsigned and undated memorandum of understanding with Sexual Trauma Awareness & Response (STAR). The auditor contacted the STAR President & CEO and confirmed STAR does not serve St. Martin Parish. The advocacy organization that serves St. Martin Parish is Hearts of Hope. Through corrective action, the agency developed a memorandum of understanding between the Louisiana Office of Juvenile Justice and Hearts of Hope effective May 28, 2024.

**115.321 (e)** Acadiana Center for Youth at St. Martinville Pre-Audit Questionnaire response: If requested by the victim, a victim advocate, or qualified agency staff member, or qualified community-based organization staff member accompanies and supports the victim through the forensic medical examination process and investigatory interviews and provides emotional support, crisis intervention, information, and referrals.

Louisiana Office of Juvenile Justice PREA Manual, 6th edition, dated 2023, page 12, section III.C.2, states as requested by the victim, the victim advocate, qualified Agency staff member or qualified community-based organization staff member shall accompany and support the victim through the forensic medical examination process and investigatory interviews, and shall provide emotional support, crisis intervention information, and referrals.

Through a review of the Hearts of Hope website, the auditor observed the Hearts of Hope Sexual Abuse Response Center (SARC) provides victim advocacy services, to include ER accompaniment, at Our Lady of Lourdes Women's & Children's Hospital.

Through corrective action, the agency developed a memorandum of understanding between the Louisiana Office of Juvenile Justice and Hearts of Hope effective May 28, 2024.

**115.321 (f)** Acadiana Center for Youth at St. Martinville Pre-Audit Questionnaire response: If the agency is not responsible for administrative or criminal investigating allegations of sexual abuse and relies on another agency to conduct these investigations, the agency has requested that the responsible agency follow the requirements of paragraphs §115.321 (a) through (e) of the standards.

The Louisiana Office of Juvenile Justice Department of Investigative Services (IS) is responsible for administrative and criminal investigations of allegations of sexual abuse.

#### **Conclusion and Corrective Action:**

Based upon the review and analysis of the available evidence, the auditor has determined the facility is fully compliant with this standard regarding evidence protocol and forensic medical examinations. Corrective action is complete.

**115.321 (d)** The standard provision requires that facility makes a victim advocate from a rape crisis center available to the victim, in person or by other means. Victim advocacy services for resident victims of sexual abuse are available from the Hearts of Hope Center for Sexual Trauma. The agency developed a memorandum of understanding between the Louisiana Office of Juvenile Justice and Hearts of Hope effective May 28, 2024.

**115.321 (e)** The standard requires, if requested by the victim, a victim advocate, or qualified agency staff member, or qualified community-based organization staff member accompanies and supports the victim through the forensic medical examination process and investigatory interviews and provides emotional support, crisis intervention, information, and referrals.

The Hearts of Hope Sexual Abuse Response Center (SARC) provides victim advocacy services, to include ER accompaniment, at Our Lady of Lourdes Women's & Children's Hospital. The agency developed a memorandum of understanding between the Louisiana Office of Juvenile Justice and Hearts of Hope effective May 28, 2024.

Referring to allegations received in the past 12 months, all administrative and/or criminal investigations were completed.

Louisiana Office of Juvenile Justice PREA Manual, 6th edition, dated 2023, page 13, section III.E.1, states an administrative or criminal investigation shall be completed for all allegations of sexual abuse and sexual harassment pursuant to YS Policy No. A.1.4.

The Chief of Operations confirmed the agency ensures that an administrative or criminal investigation is completed for all allegations of sexual abuse or sexual harassment.

The auditor reviewed 1 incident report for a pending investigation of a potential allegation of resident-on-resident sexual abuse.

**115.322 (b)** Acadiana Center for Youth at St. Martinville Pre-Audit Questionnaire response: The agency has a policy that requires that allegations of sexual abuse or sexual harassment be referred for investigation to an agency with the legal authority to conduct criminal investigations, including the agency if it conducts its own investigations, unless the allegation does not involve potentially criminal behavior. The agency's policy regarding the referral of allegations of sexual abuse or sexual harassment for a criminal investigation is published on the agency website. The agency documents all referrals of allegations of sexual abuse or sexual harassment for criminal investigation.

Louisiana Office of Juvenile Justice PREA Manual, 6th edition, dated 2023, page 13, section III.E.2-3, states allegations of sexual abuse or sexual harassment shall be

referred to IS for investigation. The IS policy shall be published on the Office of Juvenile Justice (OJJ) website at http://www.ojj.la.gov/.

The auditor observed the Louisiana Office of Juvenile Justice Policy, A.1.4: Investigative Services dated February 1, 2024, is published on the OJJ website under the URL https://ojj.la.gov/page/policies. The Louisiana Office of Juvenile Justice Department of Investigative Services has the legal authority to conduct criminal investigations.

**115.322 (c)** If a separate entity is responsible for conducting criminal investigations, such publication shall describe the responsibilities of both the agency and the investigating entity.

The Louisiana Office of Juvenile Department of Investigative Services (IS) is responsible for administrative and criminal investigations of allegations of sexual abuse.

**Conclusion:** Based upon the review and analysis of the available evidence, the auditor has determined the facility is fully compliant with this standard regarding policies to ensure referrals of allegations for investigations. No corrective action is required.

	115.331 (a) Acadiana Center for Youth at St. Martinville Pre-Audit Questionnaire

response: The agency trains all employees who may have contact with residents on

the eleven (11) required topics.

Louisiana Office of Juvenile Justice PREA Manual, 6th edition, dated 2023, page 14, section IV.A.1-2.k, states prior to having contact with youth, all staff shall be trained on how to recognize the signs of injurious sexual conduct, and understand their responsibility in the detection, prevention, investigation, and reporting of sexual abuse and sexual harassment during new employee orientation and annual inservice training. Training topics shall consist of, but not be limited to, the following:

- a. The policy of zero-tolerance for sexual abuse and sexual harassment;
- b. Fulfilling their responsibilities regarding sexual abuse and sexual harassment prevention, detection and reporting, including relevant laws related to mandatory reporting of sexual abuse to outside authorities;
- c. Youths' right to be free from sexual abuse and sexual harassment;
- d. Youths' and employees' right to be free from retaliation for reporting sexual abuse and sexual harassment;
- e. The dynamics of sexual abuse and sexual harassment in juvenile facilities;
- f. Common reactions of juvenile victims of sexual abuse and sexual harassment, including isolation, depression, etc.;
- g. Detecting and responding to signs of threatened and actual sexual abuse; sexually aggressive behavior and how to distinguish between consensual sexual contact and sexual abuse between youth;
- h. Avoiding inappropriate relationships with youth;
- i. Communicating effectively and professionally with youth, including those who are lesbian, gay, bisexual, transgender, intersex, questioning (LGBTIQ), or gender nonconforming;
- j. Relevant laws regarding the applicable age of consent; and
- k. Awareness and enforcing of policies and procedures regarding sexual conduct of youth

The auditor reviewed the Louisiana Office of Juvenile Justice PREA Training Curriculum and observed the curriculum includes all of the topics required by the standard provision. The auditor reviewed 21 Staff Confirmation of Receipts of PREA for 2023 for staff interviewed. Additionally, the auditor reviewed Louisiana Office of Juvenile Justice PREA Class Attendance Roster for PREA and observed that approximately 34 staff signed the attendance roster.

Staff interviewed confirmed they received training on the required topics.

**115.331 (b)** Acadiana Center for Youth at St. Martinville Pre-Audit Questionnaire response: Training is tailored to the unique needs and attributes and gender of the residents at the facility. Employees who are reassigned from facilities housing the opposite gender are given additional training.

Louisiana Office of Juvenile Justice PREA Manual, 6th edition, dated 2023, page 15, section IV.A.4, states training shall be tailored to the unique needs and attributes of youth of juvenile facilities and to the gender of the youth at the employee's facility. The employee shall receive additional training if the employee is reassigned from a facility that houses only male youths to a facility that houses only female youths, or vice versa.

**115.331 (c)** Acadiana Center for Youth at St. Martinville Pre-Audit Questionnaire response: Between trainings the agency provides employees who may have contact with residents with refresher information about current policies regarding sexual abuse and harassment. The frequency with which employees who may have contact with residents receive refresher training on PREA requirements: Annually

Louisiana Office of Juvenile Justice PREA Manual, 6th edition, dated 2023, page 15, section IV.A.3, states all current employees shall be provided with annual refresher training on current sexual abuse and sexual harassment policies and procedures pursuant to YS Policy No. A.2.24.

**115.331 (d)** Acadiana Center for Youth at St. Martinville Pre-Audit Questionnaire response: The agency documents that employees who may have contact with residents understand the training they have received through employee signature or electronic verification.

Louisiana Office of Juvenile Justice PREA Manual, 6th edition, dated 2023, page 15, section IV.A.5, states employee attendance and understanding of the training provided shall be documented, through employee signature on the "Staff Confirmation of Receipt" [see Attachment C.2.11 (b)], as well as entry into the "Training Records Entry Database" (TREC) pursuant to YS Policy No. A.2.24. Signed receipts shall be forwarded to PSS/HR to be filed in the employee's personnel file.

The auditor reviewed Louisiana Office of Juvenile Justice PREA Class Attendance Rosters and Staff Confirmation of Receipt of PREA and observed staff sign they have completed the required training. The Staff Confirmation of Receipt of PREA includes an acknowledgement statement that the employee has received and understands the information.

**Conclusion:** Based upon the review and analysis of the available evidence, the auditor has determined the facility is fully compliant with this standard regarding employee training. No corrective action is required.

**115.332** (a) Acadiana Center for Youth at St. Martinville Pre-Audit Questionnaire response: All volunteers and contractors who have contact with residents have been trained on their responsibilities under the agency's policies and procedures regarding sexual abuse and sexual harassment prevention, detection, and response. The number of volunteers and contractors, who have contact with residents, who have been trained in agency's policies and procedures regarding sexual abuse and sexual harassment prevention, detection, and response: 12

Louisiana Office of Juvenile Justice PREA Manual, 6th edition, dated 2023, page 15, section IV.B.1, states volunteers and contractors who have contact with youths shall be trained on their responsibilities under the Agency's sexual abuse and sexual harassment prevention, detection, and response policies and procedures. The level and type of training provided to volunteers and contractors shall be based on the services they provide and level of contact they have with youth, but all volunteers and contractors who have contact with youth shall be notified of the Agency's zero-tolerance policy regarding sexual abuse and sexual harassment and informed how to report such incidents.

Interviews with 2 volunteers and 2 contractors confirmed they have been trained on their responsibilities under OJJ's sexual abuse and sexual harassment prevention, detection, and response policies and procedures. They reported they would report to their supervisor or facility staff. The auditor reviewed training records for 3 contracted medical and mental health staff and 12 volunteers.

**115.332 (b)** Acadiana Center for Youth at St. Martinville Pre-Audit Questionnaire response: The level and type of training provided to volunteers and contractors shall be based on the services they provide and level of contact they have with residents, but all volunteers and contractors who have contact with residents shall be notified of the agency's zero-tolerance policy regarding sexual abuse and sexual harassment and informed how to report such incidents.

Louisiana Office of Juvenile Justice PREA Manual, 6th edition, dated 2023, page 15, section IV.B.1, states the level and type of training provided to volunteers and contractors shall be based on the services they provide and level of contact they have with youth.

The auditor observed contracted Wellpath staff receive the topics required by standard 115.331 and the specialized training topics required by 115.335. The training is documented with the Letters of Attestation for PREA Training.

**115.332 (c)** Acadiana Center for Youth at St. Martinville Pre-Audit Questionnaire response: The agency maintains documentation confirming that volunteers and contractors understand the training they have received.

Louisiana Office of Juvenile Justice PREA Manual, 6th edition, dated 2023, page 16 section IV.B.2, states documentation confirming that volunteers and contractors understand the training received above in Employees, Section (A) above, shall be confirmed through their signature on the "Contract Provider/Volunteer Confirmation of Receipt" [see Attachment C.2.11 (c)]. For contractors providing a service which does not require direct contact/involvement with youth (electrician, vending machine, pest control, etc.), the Agency shall utilize the "Contract Provider Confirmation Receipt for Contractors without Direct Contact with Youth" [see Attachment C.2.11 (c.1)].

The auditor reviewed Louisiana Office of Juvenile Justice PREA Class Attendance Rosters, Letters of Attestation for PREA Training, and Contract Provider/Volunteer Confirmation of Receipt of PREA and observed volunteers and contracted staff sign they have completed the required training. The Contract Provide/Volunteer Confirmation of Receipt of PREA includes an acknowledgement statement that the individual has received and understands the information.

**Conclusion:** Based upon the review and analysis of the available evidence, the auditor has determined the facility is fully compliant with this standard regarding volunteer and contractor training. No corrective action is required.

#### **Site Review Observations:**

Observations during on-site review of physical plant

#### Findings (By Provision):

**115.333 (a)** Acadiana Center for Youth at St. Martinville Pre-Audit Questionnaire response: Residents receive information at time of intake about the zero-tolerance policy and how to report incidents or suspicions of sexual abuse or sexual harassment. This information is provided in an age appropriate fashion.

Of residents admitted during the past 12 months, the number who were given this information at intake: 22

Louisiana Office of Juvenile Justice PREA Manual, 6th edition, dated 2023, page 18 section V.A.1, states upon admission to a YS secure care or contracted facility, youth shall receive: Information in an age appropriate fashion explaining the zero-tolerance policy regarding sexual abuse and sexual harassment and how to report incidents or suspicions of sexual abuse or sexual harassment.

The auditor observed the intake process. Residents are given PREA educational materials at intake. The PREA materials instruct residents about the zero-tolerance policy and how to report sexual abuse or sexual harassment. The residents also receive all of topics required for resident PREA education during intake. Residents sign the Youth Confirmation of Receipt of PREA. The intake staff stated residents transferred from other facilities are educated in the same manner as all residents.

The auditor reviewed 10 Youth Confirmation of Receipt of PREA for 10 residents interviewed. The receipts do not have an admission date to demonstrate when the education was received. Through reviewing the risk assessments, the auditor was able to determine the residents received information on the zero-tolerance policy and how to report sexual abuse or sexual harassment as well as other helpful information during intake. The facility has been open for approximately 5 months. The auditor requested the facility to provide additional Youth Confirmation of

Receipt of PREA from March 15, 2024, through June 15, 2024. The auditor reviewed the documents and observed the residents received information on the zero-tolerance policy and how to report sexual abuse or sexual harassment as well as other helpful information during intake.

Residents interviewed confirmed they were told about their right to not be sexually abused or sexually harassed, how to report sexual abuse and sexual harassment, and their right not to be punished for reporting sexual abuse or sexual harassment. Residents interviewed confirmed they were given information about the rules against sexual abuse and sexual harassment.

**115.333 (b)** Acadiana Center for Youth at St. Martinville Pre-Audit Questionnaire response: Of residents admitted during the past 12 months, the number who received such education within 10 days of intake: 22

Louisiana Office of Juvenile Justice PREA Manual, 6th edition, dated 2023, page 18 section V.A.3.a-d, states within two (2) days, but no more than ten (10) days of direct admission, comprehensive age-appropriate education shall be provided to youth by showing the OJJ designed PowerPoint presentation regarding their rights to be free from sexual abuse and sexual harassment and to be free from retaliation for reporting such incidents, and Agency policies and procedures for responding to such incidents pursuant to YS Policy No. B.2.3. The PowerPoint presentation shall include information to teach youth how to:

- a. Avoid risky situations related to sexual assault;
- b. Safely report rape or sexually inappropriate behavior;
- c. Obtain counseling services and/or medical assistance if victimized; and
- d. Evaluate the risks and potential consequences for engaging in any type of sexual contact while in the facility.

The auditor observed the residents receive all of topics required for resident PREA education during intake.

**115.333 (c)** Acadiana Center for Youth at St. Martinville Pre-Audit Questionnaire response: All residents were educated within 10 days of intake.

Louisiana Office of Juvenile Justice PREA Manual, 6th edition, dated 2023, page 18 section V.A.4, states upon transfer to a different facility, youth shall be briefed on the same information required by provision (b) within the same time parameters.

**115.333 (d)** Acadiana Center for Youth at St. Martinville Pre-Audit Questionnaire response: The agency shall provide resident education in formats accessible to all residents, including those who are limited English proficient, deaf, visually impaired, or otherwise disabled, as well as to residents who have limited reading skills.

Louisiana Office of Juvenile Justice PREA Manual, 6th edition, dated 2023, page 18 section V.A.5, states the Agency shall provide youth education in formats accessible to all youth, including those who are limited English proficient, deaf, visually impaired, or otherwise disabled, as well as to youths who have limited reading skills.

The Deputy Secretary confirmed services are in place to provide residents who are deaf or hard of hearing or residents with disabilities equal opportunity to participate in or benefit from all aspects of the agency's efforts to prevent, detect, and respond to sexual abuse and sexual harassment.

The auditor observed the facility has translation services available through a contract with 1-World Language LLC. PREA materials would be available in Braille and other formats through the contract with the Louisiana Special School District. Special education teachers and mental health staff are available as needed. The Youth PREA Orientation is available in English and Spanish. The Youth Safety Guide Pamphlet is also available in English and Spanish.

The auditor was able to test the availability of language translation through information provided by the agency. During the mock intake, the Social Services Supervisor contacted the interpreter service through instructions provided by Louisiana Office of Juvenile Justice Policy, B.8.5: Language Assistance Services dated May 4, 2023.

No residents with a cognitive or functional disability were identified during the onsite phase of the audit. There were no residents who are limited English proficient identified during the onsite phase of the audit.

**115.333 (e)** Acadiana Center for Youth at St. Martinville Pre-Audit Questionnaire response: The agency maintains documentation of resident participation in PREA education sessions.

Louisiana Office of Juvenile Justice PREA Manual, 6th edition, dated 2023, page 19 section V.A.6, states the agency shall maintain documentation of a youth's participation in these education sessions. Secure care staff shall ensure the youth signs a "Youth Confirmation of Receipt" during the orientation/admission process, and files it in the youth's hard copy Master Record under Clip VIII. Secure care staff shall ensure youth signs a "Youth Confirmation of Receipt" form again upon transfer to a different facility as indicated in Section V.A.4.

Residents sign an acknowledgement, the Youth Confirmation of Receipt of PREA, verifying they reviewed and understand the information given to them about PREA. The auditor reviewed 10 examples for verification.

**115.333 (f)** Acadiana Center for Youth at St. Martinville Pre-Audit Questionnaire response: The agency ensures that key information about the agency's PREA policies is continuously and readily available or visible through posters, resident handbooks, or other written formats.

Louisiana Office of Juvenile Justice PREA Manual, 6th edition, dated 2023, page 19 section V.A.7, states the Agency shall ensure that key information is continuously and readily available or visible to youths through posters, youth handbooks or other written formats.

The auditor observed signage contains incorrect information for reporting. The No

Means No Posters incorrectly identifies STAR as a way for residents to report abuse or harassment to a public or private entity or office that is not part of the agency. The Break the Silence Poster incorrectly identifies LaFASA as a way for residents to report abuse or harassment to a public or private entity or office that is not part of the agency. Both STAR and LaFASA receive federal grants that prevent them from being able to immediately forward resident reports of sexual abuse and sexual harassment to agency officials. Through corrective action, the Break the Silence Poster was corrected to identify LaFASA as an outside service provider that provides residents with emotional support services related to sexual abuse and the No Means No poster was corrected to identify the State of Louisiana Child Ombudsman as a way for residents to report abuse or harassment to a public or private entity or office that is not part of the agency.

**Conclusion and Corrective Action:** Based upon the review and analysis of the available evidence, the auditor has determined the facility is fully compliant with this standard regarding resident education. Corrective action is complete.

**115.333** (a) The auditor requested the facility to provide additional Youth Confirmation of Receipt of PREA from March 15, 2024, through June 15, 2024, to better enable determination of compliance with the standard provision requirements. The auditor reviewed the documents and observed the residents received information on the zero-tolerance policy and how to report sexual abuse or sexual harassment as well as other helpful information during intake.

**115.333 (f)** The No Means No Posters was corrected to remove STAR as a way for residents to report abuse or harassment to a public or private entity or office that is not part of the agency July 26, 2024. The corrected posters identify the State of Louisiana Child Ombudsman as a way for residents to report abuse or harassment to a public or private entity or office that is not part of the agency.

The Break the Silence Poster was corrected July 26, 2024, to clarify LaFASA is an outside resource for emotional support services, and not for reporting sexual abuse or sexual harassment.

The facility provided pictures of the posted corrected signage July 26, 2024.

**115.334 (a)** Acadiana Center for Youth at St. Martinville Pre-Audit Questionnaire response: Agency policy requires that investigators are trained in conducting sexual abuse investigations in confinement settings.

Louisiana Office of Juvenile Justice PREA Manual, 6th edition, dated 2023, page 16, section IV.C.2.a, states investigators shall have received training in conducting sex abuse investigations in confinement settings.

The auditor reviewed annual training required by §115.331 and NIC certificates for PREA: Investigating Sexual Abuse in a Confinement Setting and PREA: Investigating Sexual Abuse in a Confinement Setting: Advanced Investigations. The training was completed by the Louisiana Office of Juvenile Justice Department of Investigative Services investigator.

**115.334 (b)** Louisiana Office of Juvenile Justice PREA Manual, 6th edition, dated 2023, page 16, section IV.C.2.b, states specialized training shall include techniques for interviewing juvenile sexual abuse victims, proper use of Miranda and Garrity warnings, sexual abuse evidence collection in confinement settings, and the criteria and evidence required to substantiate a case for administrative action or prosecution referral, pursuant to YS Policy No. A.1.4.

Training is accomplished through online training presented by the National Institute of Corrections. An interview with the investigator confirmed he has received the required training. Additionally, the auditor reviewed training records for verification the training was completed.

**115.334 (c)** Acadiana Center for Youth at St. Martinville Pre-Audit Questionnaire response: The agency maintains documentation showing that investigators have completed the required training. The number of investigators currently employed who have completed the required training: 3

Louisiana Office of Juvenile Justice PREA Manual, 6th edition, dated 2023, page 16, section IV.C.2.a, states required training shall be documented in TREC, Success Factors and/or Corner Stone.

The auditor reviewed documented annual training required by §115.331 and NIC

certificates for PREA: Investigating Sexual Abuse in a Confinement Setting.

**Conclusion:** Based upon the review and analysis of the available evidence, the auditor has determined the facility is fully compliant with this standard regarding specialized training for investigations. No corrective action is required.

Louisiana Office of Juvenile Justice PREA Manual, 6th edition, dated 2023, page 17, section IV.D.1.a-d, states all full- and part-time medical and mental health care

at this facility who received the training required by agency policy: 100%

practitioners who work regularly in its facilities shall be trained in the methods of and procedures to:

- a. Detecting and assessing signs of sexual abuse and sexual harassment;
- b. Preserving physical evidence of sexual abuse;
- c. Responding effectively and professionally to juvenile victims of sexual abuse and sexual harassment; and
- d. Reporting allegations or suspicions of sexual abuse and sexual harassment.

The auditor observed the Mental Health Professional completed the NIC Training for PREA: Behavioral Health Care for Sexual Assault Victims in a Confinement Setting and received a certificate of completion dated October 6, 2023.

The PREA Coordinator confirmed training for the other medical and mental health staff for the specialized training topics was unable to be accomplished through online training presented by the National Institute of Corrections, due to the service being unavailable for system maintenance. As an alternative, the PREA Medical and Mental Care Standards Curriculum, developed by the National Commission on Correctional Health Care (NCCHC) and available through the PREA Resource Center website, was used as a training curriculum for the specialized topics. The medical and mental health staff signed Letters of Attestation for PREA Training to document having completed the training. The auditor reviewed 2 Letters of Attestation for PREA Training and observed the specialized training topics were received by the staff. Additionally, interviews with medical and mental health staff confirmed they received the specialized training topics regarding sexual abuse and sexual harassment.

**115.335 (b)** Acadiana Center for Youth at St. Martinville Pre-Audit Questionnaire response: OJJ does not employee medical staff that conduct forensic exams. Forensic medical examinations are performed offsite.

Interviews with medical and mental health staff confirmed forensic medical examinations are not conducted at the facility. Forensic examinations are performed offsite at Our Lady of Lourdes Women's & Children's Hospital.

**115.335 (c)** Acadiana Center for Youth at St. Martinville Pre-Audit Questionnaire response: The agency maintains documentation showing that medical and mental health practitioners have completed the required training.

Louisiana Office of Juvenile Justice PREA Manual, 6th edition, dated 2023, page 17, section IV.D.2, states documentation that medical and mental health practitioners have received the training referenced in Section IV.D.1 above from the Agency shall be documented through signature on the "Staff Confirmation of Receipt", pursuant to YS Policy No. A.2.24. Receipts shall be maintained in the CHP employee's file with a copy forwarded to the unit's designated training staff for filing.

Documentation that the training referenced in Section IV.D.1 above was received elsewhere shall be maintained in the CHP employee's file with a copy forwarded to the unit's designated training staff for filing.

The auditor reviewed training records, an NIC certificate, and Letters of Attestation for PREA Training for 3 medical and mental health staff and observed the training has been received.

**115.335 (d)** Louisiana Office of Juvenile Justice PREA Manual, 6th edition, dated 2023, page 17, section IV.D.3, states medical and mental health care practitioners shall also receive the training mandated for employees under Section IV.A above, or for contractors and volunteers under Section IV.B above, depending upon the practitioner's status at the Agency. Receipts shall be maintained in the CHP employee's file with a copy forwarded to the unit's designated training staff for filing.

The medical and mental health staff are contracted through Wellpath. The auditor reviewed training sign in sheets for 2023, an NIC certificate, and the Letters of Attestation for PREA Training and observed the staff received the topics required by Standard 115.331 and the specialized training topics required by Standard 115.335, provision (a).

**Conclusion:** Based upon the review and analysis of the available evidence, the auditor has determined the facility is fully compliant with this standard regarding specialized training for medical and mental health care. No corrective action is required.

#### Findings (By Provision):

**115.341 (a)** Acadiana Center for Youth at St. Martinville Pre-Audit Questionnaire response: The agency has a policy that requires screening (upon admission to a facility or transfer to another facility) for risk of sexual abuse victimization or sexual abusiveness toward other residents. The policy requires that residents be screened for risk of sexual victimization or risk of sexually abusing other residents within 72 hours of their intake.

In the past 12 months: The number of residents entering the facility (either through intake or transfer) whose length of stay in the facility was for 72 hours or more who were screened for risk of sexual victimization or risk of sexually abusing other residents within 72 hours of their entry into the facility: 21

The percent of residents entering the facility (either through intake or transfer) whose length of stay in the facility was for 72 hours or more who were screened for risk of sexual victimization or risk of sexually abusing other residents within 72 hours of their entry into the facility: 100%

The policy requires that a resident's risk level be reassessed at 30 days and every 6 months there afterward.

Louisiana Office of Juvenile Justice PREA Manual, 6th edition, dated 2023, page 19, section VI.A.1.a, states within 72 hours of the youth's arrival at the facility, 30 days from youth's arrival at the facility, each full SAVRY reassessment, after a PREA Incident, and if the youth is at substantial risk of imminent sexual abuse, the Agency shall obtain and use information about each youth's personal history and behavior to reduce the risk of sexual abuse by or upon a youth.

The auditor reviewed 10 completed initial risk screens for the 12-month audit period and for resident interviewed. Of the initial risk screens all were completed within 72 hours of admission. The auditor reviewed 10 30-day risk reassessments for residents interviewed and for the 12-month audit period. The auditor observed the risk reassessments were being completed according to agency policy. Due to the facility having been open for approximately 5 months, the auditor requested the facility provide additional initial risk assessments and risk reassessments, to include 6-month reassessments, from March 15, 2024, through June 15, 2024, to better enable determination of compliance with the standard provision requirements. The auditor observed the risk assessments were conducted within the required time frames.

Documentation review and the interview with the Staff that Performs Screening for Risk of Victimization and Abusiveness (Social Services Supervisor) confirmed residents are screened upon admission to the facility or transfer from another facility for risk of sexual abuse victimization or sexual abusiveness toward the other

residents. The risk screening occurs with 72 hours of intake. Additionally, the Social Services Supervisor confirmed risk levels are reassessed at 30 days and every 6 months. The reassessments were conducted quarterly before the January 2023 policy change to 30 days after intake and then every 6 months afterward.

The residents interviewed who entered the facility within the past twelve months confirmed they were asked questions like the following examples at intake:

- 1. Have you have ever been sexually abused?
- 2. Do you identify with being gay, bisexual or transgender?
- 3. Do you have any disabilities?
- 4. Do you think you might be in danger of sexual abuse at the facility?
- **115.341 (b)** Acadiana Center for Youth at St. Martinville Pre-Audit Questionnaire response: Risk assessment is conducted using an objective screening instrument.

Louisiana Office of Juvenile Justice PREA Manual, 6th edition, dated 2023, page 19, section VI.A.1.c, states assessments shall be conducted using the "Intake & Quarterly Staffing Screening and Housing Assessment" objective screening instrument.

The auditor observed the objective screening instrument, examples for residents interviewed, and additional examples for the 12-month audit period. Additionally, the PREA Coordinator provided a statement that states the screening instrument is currently being reviewed and studied by the agency and the Moss Group (5/09/2023).

- **115.341 (c)** Louisiana Office of Juvenile Justice PREA Manual, 6th edition, dated 2023, page 20, section VI.A.1.d, states at a minimum, the agency shall attempt to ascertain information about:
- 1. Prior sexual victimization or abusiveness;
- 2. Any gender nonconforming appearance or manner or identification as lesbian, gay, bisexual, transgender, or intersex, and whether the resident may therefore be vulnerable to sexual abuse;
- 3. Current charges and offense history;
- 4. Age;
- 5. Level of emotional and cognitive development;
- 6. Physical size and stature;
- 7. Mental illness or mental disabilities;
- 8. Intellectual, physical, or developmental disabilities;
- 9. Youth's own perception of vulnerability; and
- 10. Any other specific information about individual residents that may indicate heightened needs for supervision, additional safety precautions, or separation from certain other residents.

The agency updated the screening tool to include level of cognitive development (7/2022). Additionally, the agency is currently working toward developing a new screening tool, inclusive of all screening criteria, with the assistance of the Moss Group (5/23/2023).

**115.341 (d)** Louisiana Office of Juvenile Justice PREA Manual, 6th edition, dated 2023, page 20, section VI.A.1.e, states the information shall be ascertained through conversations with the youth during the direct admission process; medical and mental health screenings; classification assessments; and by reviewing court records, case files, facility behavioral records, and other relevant documentation from the youth's files.

The interview with the Social Services Supervisor confirmed the information is ascertained through observations and conversations with the residents using the Intake & Quarterly Staffing Screening and Housing Assessment. Collateral information is referred to when applicable.

**115.341 (e)** Louisiana Office of Juvenile Justice PREA Manual, 6th edition, dated 2023, page 20, section VI.A.1.f, states each facility through procedures established in its Standard Operating Procedures (SOPs) shall implement appropriate controls on the dissemination within the facility of responses to questions asked pursuant to this standard in order to ensure that sensitive information is not exploited to the youth's detriment by staff or other youths.

The auditor observed the files are maintained securely in a locked file cabinet. The PREA Coordinator, PREA Compliance Manager and Social Services Supervisor confirmed the agency has outlined who can have access to a resident's risk assessment within the facility, in order to protect sensitive information from exploitation.

**Conclusion and Corrective Action:** Based upon the review and analysis of the available evidence, the auditor has determined the facility is fully compliant with this standard regarding screening for risk of victimization and abusiveness. Corrective action is complete.

**115.341 (a)** Due to the facility only being open for 5 months, the auditor requested additional initial risk assessments, 30-day risk reassessments, and 6-month risk reassessments from March 15, 2024, through June 15, 2024 to better enable determination of compliance with the standard provision requirements. The auditor observed the risk assessments were conducted within the required time frames.

Observations during on-site review of physical plant

#### **Findings (By Provision):**

**115.342 (a)** Acadiana Center for Youth at St. Martinville Pre-Audit Questionnaire response: The agency/facility uses information from the risk screening required by §115.341 to inform housing, bed, work, education, and program assignments with the goal of keeping all residents safe and free from sexual abuse.

Louisiana Office of Juvenile Justice PREA Manual, 6th edition, dated 2023, page 22, section VI.D.1-2, states Facility Directors and Contract providers shall use all information initially obtained in and subsequently obtained to make housing, bed, program, education, and work assignments for youth with the goal of keeping all youth safe and free from sexual abuse. Youth shall be reevaluated by their assigned Case Manager during the "Monthly Assessment of IIP Progress" pursuant to YS Policy No. B.2.2, to determine if the housing area assignment continues to meet their needs.

The PREA Compliance Manager confirmed the facility uses information from the risk screening during intake to keep residents safe and free from sexual abuse and sexual harassment by determining housing and programming assignments. She

stated the facility uses the information from the risk assessment and meets as a team to determine the best placement for the youth to keep them safe from sexual abuse and sexual harassment.

The auditor observed the risk assessment creates a score for sexual vulnerability and/or abusiveness. The auditor observed computerized alerts are generated based on risk level. The auditor requested the agency to provide documented evidence of how the information from the risk screening is used to inform housing, bed, work, education, and program assignments with the goal of keeping all residents safe and free from sexual abuse. The agency provided a corrective action statement on April 30, 2024 detailing how the information will used to generate alerts and how the information will be shared with facility departments to inform housing, bed, work, education, and program assignments. To demonstrate the procedures have been fully implemented, the auditor requested documented evidence from May 1, 2024, to July 31, 2024. The facility developed Individual Intervention Plans and provided 9 examples July 15, 2004. Individual Intervention Plans document a resident's risk of sexual victimization or risk of sexually abusing other residents. The plans are completed during the initial staffing, quarterly thereafter, and follow a resident throughout their confinement at the facility. The auditor reviewed the Individual Intervention Plan examples and observed detailed staff monitoring requirements based on risk and strengths.

**115.342 (b)** Acadiana Center for Youth at St. Martinville Pre-Audit Questionnaire response: The facility has a policy that residents at risk of sexual victimization may only be placed in isolation as a last resort if less restrictive measures are inadequate to keep them and other residents safe, and only until an alternative means of keeping all residents safe can be arranged. The facility policy requires that residents at risk of sexual victimization who are placed in isolation have access to legally required educational programming, special education services, and daily largemuscle exercise.

#### In the past 12 months:

- The number of residents at risk of sexual victimization who were placed in isolation: 0
- The number of residents at risk of sexual victimization who were placed in isolation who have been denied daily access to large muscle exercise, and/or legally required education, or special education services: 0
- The average period of time residents at risk of sexual victimization who were held in isolation to protect them from sexual victimization: N/A

Louisiana Office of Juvenile Justice PREA Manual, 6th edition, dated 2023, page 22, section VI.D.3-4, states youth may be isolated from others only as a last resort when less restrictive measures are inadequate to keep all youth safe, and then only until an alternative means of keeping all youth safe can be arranged, pursuant to YS Policy No. B.2.8.

During any period of isolation youth shall not be denied daily large-muscle exercise and any legally required educational programming or special education services. Youth shall receive daily visits from a medical or mental health care clinician. Youth shall also have access to other programs and work opportunities to the extent possible.

The Facility Director confirmed Acadiana Center for Youth at St. Martinville has not used isolation for residents at risk of sexual victimization.

**115.342 (c)** Acadiana Center for Youth at St. Martinville Pre-Audit Questionnaire response: The facility prohibits placing lesbian, gay, bisexual, transgender, or intersex residents in particular housing, bed, or other assignments solely on the basis of such identification or status. The facility prohibits considering lesbian, gay, bisexual, transgender, or intersex identification or status as an indicator of likelihood of being sexually abusive.

Louisiana Office of Juvenile Justice PREA Manual, 6th edition, dated 2023, page 22, section VI.D.6, states LGBTIQ youth shall not be placed in particular housing, bed, or other assignments solely on the basis of such identification or status, nor shall LGBTIQ identification or status be considered as an indicator of likelihood of being sexually abusive.

The PREA Coordinator and PREA Compliance Manager both confirmed the facility does not have a special housing unit for lesbian, gay, bisexual, transgender, or intersex residents.

One resident identified as transgender. The resident stated he has not been placed in a special housing unit for lesbian, gay, bisexual, transgender, or intersex residents.

Site review: The auditor observed the housing units. There was no particular housing, bed, or other assignments of lesbian, gay, bisexual, transgender, or intersex residents solely on the basis of such identification or status.

**115.342 (d)** Acadiana Center for Youth at St. Martinville Pre-Audit Questionnaire response: The agency or facility makes housing and program assignments for transgender or intersex residents in the facility on a case-by-case basis.

Louisiana Office of Juvenile Justice PREA Manual, 6th edition, dated 2023, page 22, section VI.D.7, states in assigning a transgender or intersex youth to a facility for male or female youth, and in making other housing and programming assignments, the Agency shall consider on a case-by-case basis whether a placement would ensure the youth's health and safety, and whether the placement would present management or security problems.

The PREA Compliance Manager confirmed housing and programming assignments for transgender male, transgender female, or intersex residents are made on a case-by-case basis whether a placement would ensure the resident's health and safety, and whether the placement would present management or security problems.

One resident identified as transgender during the onsite phase of the audit. He

confirmed staff have considered safety in determining housing and program assignments. The auditor reviewed documentation of the agency decisions for placement with the resident's health and safety considered.

**115.342 (e)** Acadiana Center for Youth at St. Martinville Pre-Audit Questionnaire response: Placement and programming assignments for each transgender or intersex resident shall be reassessed at least twice each year to review any threats to safety experienced by the resident.

Louisiana Office of Juvenile Justice PREA Manual, 6th edition, dated 2023, page 22, section VI.D.8, states placement and programming assignments for each transgender or intersex youth shall be reassessed at least twice each year to review any threats to safety experienced by the youth.

The PREA Compliance Manager and Staff Responsible for Risk Screening confirmed placement and programming assignments are reassessed at least twice each year to review any threats to safety experienced by the resident.

**115.342 (f)** Acadiana Center for Youth at St. Martinville Pre-Audit Questionnaire response: A transgender or intersex resident's own views with respect to his or her own safety shall be given serious consideration.

Louisiana Office of Juvenile Justice PREA Manual, 6th edition, dated 2023, page 22, section VI.D.9, states a transgender or intersex youth's views with respect to his/her safety shall be given serious consideration.

The PREA Compliance Manger confirmed the agency considers whether placement will ensure a resident's health and safety and the intake staff responsible for risk screening confirmed transgender or intersex residents' views of their safety are given serious consideration in placement and programming assignments.

**115.342 (g)** Acadiana Center for Youth at St. Martinville Pre-Audit Questionnaire response: Transgender and intersex residents shall be given the opportunity to shower separately from other residents.

Louisiana Office of Juvenile Justice PREA Manual, 6th edition, dated 2023, page 23, section VI.D.10, states transgender and intersex youth shall be given the opportunity to shower separately from other youth.

The PREA Coordinator and Staff Responsible for Risk Screening confirmed transgender and intersex residents are given the opportunity to shower separately from other residents.

One resident identified as transgender during the onsite phase of the audit. The resident confirmed he is able to shower separately from other residents.

Site Review: The auditor observed all residents shower individually in the privacy of a shower with a shower curtain.

115.342 (h) Acadiana Center for Youth at St. Martinville Pre-Audit Questionnaire

response: From a review of case files of residents at risk of sexual victimization who were held in isolation in the past 12 months, the number of case files that include BOTH:

- A statement of the basis for facility's concern for the resident's safety, and
- The reason or reasons why alternative means of separation cannot be arranged: N/A

No residents at risk of sexual victimization were held in isolation in the past 12 months.

**115.342 (i)** Acadiana Center for Youth at St. Martinville Pre-Audit Questionnaire response: If a resident at risk of sexual victimization is held in isolation, the facility affords each such resident a review every 30 days to determine whether there is a continuing need for separation from the general population.

No residents at risk of sexual victimization were held in isolation in the past 12 months. Acadiana Center for Youth at St. Martinville has not used isolation for this purpose of residents at risk of sexual victimization.

**Conclusion and Corrective Action:** Based upon the review and analysis of the available evidence, the auditor has determined the facility is fully compliant with this standard regarding use of screening information. Corrective action is complete.

**115.342 (a)** The agency shall use all information obtained pursuant to § 115.341 and subsequently to make housing, bed, program, education, and work assignments for residents with the goal of keeping all residents safe and free from sexual abuse.

The agency provided a corrective action statement on April 30, 2024, detailing how the information will used to generate alerts and how the information will be shared with facility departments to inform housing, bed, work, education, and program assignments. To show the procedures have been fully implemented, the auditor requested documented evidence from May 1, 2024 to July 31, 2024. The facility developed Individual Intervention Plans and provided 9 examples July 15, 2004. Individual Intervention Plans document a resident's risk of sexual victimization or risk of sexually abusing other residents. The plans are completed during the initial staffing, quarterly thereafter, and follow a resident throughout their confinement at the facility. The auditor reviewed the Individual Intervention Plan examples and observed detailed staff monitoring requirements based on risk and strengths.

# **Findings (By Provision):**

**115.351** (a) Acadiana Center for Youth at St. Martinville Pre-Audit Questionnaire response: The agency has established procedures allowing for multiple internal ways for residents to report privately to agency officials about: Sexual abuse or sexual harassment; Retaliation by other residents or staff for reporting sexual abuse and sexual harassment; AND Staff neglect or violation of responsibilities that may have contributed to such incidents.

Louisiana Office of Juvenile Justice PREA Manual, 6th edition, dated 2023, page 23, section VII.A.3, states there shall be multiple internal methods provided for youth to privately report sexual abuse and sexual harassment, retaliation by other youths or staff for reporting sexual abuse and sexual harassment, and staff neglect or violation of responsibilities that may have contributed to such incidents.

Staff interviews confirmed residents can privately report sexual abuse or sexual harassment, retaliation by other residents or staff for reporting sexual abuse and sexual harassment, or staff neglect or violation of responsibilities that may have contributed to an incident of sexual abuse or sexual harassment by calling the hotline number, telling staff, or writing a grievance. Residents stated they would report sexual abuse or sexual harassment that happened to them or someone else

by telling staff, calling the hotline, or writing a grievance.

The auditor observed posters are located throughout the facility, including next to the telephones. The "No Means No" poster provides residents with numerous methods for reporting both internally and externally. Internal methods include: IS hotline, verbally, administrative remedy procedure (ARP), anonymously, or by third party. The posters are in English and Spanish. The posters were in a large font and not obscured by graffiti or damaged.

The auditor tested the internal reporting methods. The auditor successfully tested the grievance system. A response was received the following day. The auditor tested the telephones. The auditor was unable to place a call to Investigative Services by following instructions included on the No Means No poster. Through corrective action, the facility corrected the poster to include accurate calling instructions on March 11, 2024, and the final version was created July 27, 2024. The auditor was able to successfully call Investigative Services with the corrected instructions.

**115.351 (b)** Acadiana Center for Youth at St. Martinville Pre-Audit Questionnaire response: The agency provides at least one way for residents to report abuse or harassment to a public or private entity or office that is not part of the agency. DYS does not detain youth solely for civil immigration purposes.

Louisiana Office of Juvenile Justice PREA Manual, 6th edition, dated 2023, page 23, section VII.A.4, states youth shall be provided at least one method to report abuse or harassment to a public or private entity or office that is not part of OJJ and that is able to receive and immediately forward youth reports of sexual abuse and sexual harassment to Agency officials, allowing the youth to remain anonymous upon request. This shall be accomplished by calling the third party outside reporting source found posted throughout the facility.

The PREA Compliance Manager confirmed residents can report sexual abuse or sexual harassment to a public or private entity that is not part of the agency.

Residents stated they would report sexual abuse or sexual harassment that happened to them or someone else by telling staff, calling the hotline, or writing a grievance. Residents also could identify someone that does not work at the facility they could report to.

The auditor observed the "No Means No" poster provided residents with contact information for STAR. The auditor contacted the STAR President & CEO and confirmed STAR does not serve St. Martin Parish and confirmed the agency receives federal grants that prevent them from being able to immediately forward resident reports of sexual abuse and sexual harassment to agency officials. Through corrective action, the agency developed a memorandum of understanding with the State of Louisiana Child Ombudsman June 11, 2024, to provide at least one way for residents to report abuse or harassment to a public or private entity or office that is not part of the agency and that is able to receive and immediately forward resident reports of sexual abuse and sexual harassment to agency officials, allowing the resident to remain anonymous upon request. Additionally, the "No Means No" poster

was updated to reflect this change July 27, 2024.

The auditor observed the Break the Silence poster incorrectly identified LaFASA as a method for reporting sexual abuse or sexual harassment. Through corrective action, the Break the Silence Poster was corrected July 27, 2024, to identify LaFASA as an outside service provider that provides residents with emotional support services related to sexual abuse.

**115.351 (c)** Acadiana Center for Youth at St. Martinville Pre-Audit Questionnaire response: The agency has a policy mandating that staff accept reports of sexual abuse and sexual harassment made verbally, in writing, anonymously, and from third parties. Staff are required to document verbal reports. The time frame that staff are required to document verbal reports: immediately

Louisiana Office of Juvenile Justice PREA Manual, 6th edition, dated 2023, page 23, section VII.A.5, states staff shall accept reports made verbally, in writing, anonymously, and from third parties and shall promptly document any verbal reports.

Staff interviews confirmed reports can be made verbally, in writing, anonymously, and from third parties. Most staff interviewed stated they would document verbal reports immediately. Reports would be made to their direct supervisor and Investigative Services. Residents interviewed acknowledged they could report verbally or in writing. If they wanted to make a report without having to give their name a relative or friend could make the report for them.

**115.351 (d)** Acadiana Center for Youth at St. Martinville Pre-Audit Questionnaire response: The facility provides residents with access to tools to make written reports of sexual abuse or sexual harassment, retaliation by other residents or staff for reporting sexual abuse and sexual harassment, and staff neglect or violation of responsibilities that may have contributed to such incidents.

Louisiana Office of Juvenile Justice PREA Manual, 6th edition, dated 2023, page 23, section VII.A.6, states the facility shall provide youth with access to tools necessary to make a written report.

The PREA Compliance Manager confirmed grievance forms are available and locked grievance boxes are provided.

The auditor observed the availability of writing utensils, grievance forms, and locked grievance boxes.

**115.351 (e)** Acadiana Center for Youth at St. Martinville Pre-Audit Questionnaire response: The agency has established procedures for staff to privately report sexual abuse and sexual harassment of residents.

Louisiana Office of Juvenile Justice PREA Manual, 6th edition, dated 2023, page 24, section VII.A.7, states staff shall be able to privately report sexual abuse and sexual harassment of youth by calling the IS Hotline at 1- 800-626-1430, and reporting an allegation directly to IS.

Staff interviews confirmed they were knowledgeable they could privately report sexual abuse and sexual harassment of residents. Most staff named the IS Hotline.

**Conclusion and Corrective Action:** Based upon the review and analysis of the available evidence, the auditor has determined the facility is fully compliant with this standard regarding resident reporting. Corrective action is complete.

**115.351 (a)** The posters were updated to reflect correct calling instructions to IS. The facility provided pictures of the corrected signage March 11, 2024, and the final version was created July 27, 2024.

# 115.351 (b)

- The agency developed a memorandum of understanding with the State of Louisiana Child Ombudsman June 11, 2024, to provide at least one way for residents to report abuse or harassment to a public or private entity or office that is not part of the agency and that is able to receive and immediately forward resident reports of sexual abuse and sexual harassment to agency officials, allowing the resident to remain anonymous upon request.
- The No Means No posters were updated to indicate the external reporting entity as the State of Louisiana Child Ombudsman and pictures of updated signage were provided to the auditor July 27, 2024.
- Telephones were programmed with the State of Louisiana Child Ombudsman July 18, 2024.
- The facility conducted a successful documented test call, demonstrating a report of sexual abuse or sexual harassment will be immediately forwarded to the facility July 25, 2024.
- The Break the Silence Poster was corrected to indicate LaFASA is an external resource for emotional support services and is not for reporting sexual abuse or sexual harassment July 27, 2024.

**115.352 (a)** Acadiana Center for Youth at St. Martinville Pre-Audit Questionnaire response: The agency has an administrative procedure for dealing with resident grievances regarding sexual abuse.

Louisiana Office of Juvenile Justice Policy, B.5.3: Administrative Remedy Procedure dated December 8, 2022, addresses resident grievances regarding sexual abuse.

The auditor reviewed the Administrative Remedy Procedures and verified relevant information is provided. Additionally, the auditor observed grievance forms are available without being requested. Grievances are placed in a locked grievance box that is checked daily. The auditor successfully tested the grievance system. A response was received by email the following day.

**115.352 (b)** Acadiana Center for Youth at St. Martinville Pre-Audit Questionnaire response: Agency policy or procedure allows a resident to submit a grievance regarding an allegation of sexual abuse at any time regardless of when the incident is alleged to have occurred. Agency policy does not require a resident to use an informal grievance process, or otherwise to attempt to resolve with staff, an alleged incident of sexual abuse.

Louisiana Office of Juvenile Justice PREA Manual, 6th edition, dated 2023, page 24, section VII.B.1-3, states pursuant to YS Policy No. B.5.3, the Administrative Remedy Procedure (ARP) shall not contain a time limit on when a youth may submit a grievance regarding an allegation of sexual abuse. The Agency may apply otherwise-applicable time limits on any portion of a grievance that does not allege an incident of sexual abuse. A youth shall not be required to use any informal grievance process, or to otherwise attempt to resolve with staff, an alleged incident of sexual abuse. The provisions of subparagraphs (1) and (2) do not restrict the Agency's ability to defend against a lawsuit filed by a youth on the ground that the applicable statute of limitations has expired.

The auditor reviewed the Administrative Remedy Procedure and verified relevant information is provided. Residents are given the Administrative Remedy Procedure (ARP): How to Complain About Your Problem Handout explaining the ARP process.

**115.352 (c)** Acadiana Center for Youth at St. Martinville Pre-Audit Questionnaire response: The agency's policy and procedure allow a resident to submit a grievance alleging sexual abuse without submitting it to the staff member who is the subject of the complaint.

Louisiana Office of Juvenile Justice PREA Manual, 6th edition, dated 2023, page 24, section VII.B.4, states the Agency shall ensure that a youth who alleges sexual abuse may submit a grievance without submitting it to a staff member who is the subject of the complaint, and such grievance is not referred to a staff member who is the subject of the complaint.

The auditor reviewed the Administrative Remedy Procedure and verified relevant information is provided. Residents are given the Administrative Remedy Procedure (ARP): How to Complain About Your Problem Handout explaining the ARP process.

**115.352 (d)** Acadiana Center for Youth at St. Martinville Pre-Audit Questionnaire response: The agency has policy and procedures that require that a decision on the merits of any grievance or portion of a grievance alleging sexual abuse be made within 90 days of the filing of the grievance.

In the past 12 months:

Louisiana Office of Juvenile Justice PREA Manual, 6th edition, dated 2023, pages 24-25, section VII.B.5-7, states the ARP shall require a final Agency decision on the merits of any portion of a grievance alleging sexual abuse be issued within 90 days of the initial filing of the grievance. Computation of the 90-day time period shall not include time used by the youth in preparing any administrative appeal. Pursuant to B.5.3, the ARP may provide for a request for an extension of time by the Facility Director to respond in Step One with the approval of the Deputy Secretary if the normal time period for response is insufficient to make an appropriate decision. The Facility Director shall notify the youth in writing of any such extension and provide a date by which a decision will be made. At any level of the administrative process, including the final level, if the youth does not receive a response within the time allotted for reply, including any properly noticed extension, the youth may consider the absence of a response to be a denial at that level.

**115.352 (e)** Acadiana Center for Youth at St. Martinville Pre-Audit Questionnaire response: The number of the grievances alleging sexual abuse filed by residents in the past 12 months in which the resident declined third-party assistance, containing documentation of the resident's decision to decline: 0

Louisiana Office of Juvenile Justice PREA Manual, 6th edition, dated 2023, page 25, section VII.B.8-11, states third parties, including fellow youth, staff members, family members, attorneys, and outside advocates, shall be permitted to assist youth in

filing requests for an ARP relating to allegations of sexual abuse, and shall also be permitted to file such requests on behalf of youths. If a third party, other than a parent or legal guardian, files such a request on behalf of a youth, the ARP may require as a condition of processing the request that the alleged victim agree to have the request filed on his or her behalf and may also require the alleged victim to personally pursue any subsequent steps in the ARP. If the youth declines to have the request processed on his or her behalf, the Agency shall document the youth's decision. If an attorney files an ARP on behalf of the youth, a letter of representation shall be required. A parent or legal guardian of a juvenile shall be allowed to file a grievance regarding allegations of sexual abuse, including appeals, on behalf of such juvenile. Such a grievance shall not be conditioned upon the juvenile agreeing to have the request filed on his or her behalf.

The auditor observed signage is consistent and includes information for reporting sexual abuse and sexual harassment through the grievance process. The posters are in English and Spanish. The posters were in a large font and not obscured by graffiti or damaged.

**115.352 (f)** Acadiana Center for Youth at St. Martinville Pre-Audit Questionnaire response: The agency has a policy and established procedures for filing an emergency grievance alleging that a resident is subject to a substantial risk of imminent sexual abuse. Agency policy and procedures for emergency grievances alleging substantial risk of imminent sexual abuse require an initial response within 48 hours. The number of emergency grievances alleging substantial risk of imminent sexual abuse that were filed in the past 12 months: 0

Louisiana Office of Juvenile Justice PREA Manual, 6th edition, dated 2023, page 25, section VII.B.12.a-b, states the ARP shall contain procedures for the filing of an emergency grievance alleging that a youth is subject to a substantial risk of imminent sexual abuse. After receiving an emergency grievance alleging a youth is subject to a substantial risk of imminent sexual abuse, the Agency shall require the grievance (or any portion thereof that alleges the substantial risk of imminent sexual abuse) be immediately forwarded to the appropriate Regional Director for immediate corrective action, an initial response within 48 hours, and a final Agency decision within five (5) calendar days. The initial response and final Agency decision shall document the Agency's findings as to whether the youth is in substantial risk of imminent sexual abuse and the action taken in response to the emergency grievance.

**115.352 (g)** Acadiana Center for Youth at St. Martinville Pre-Audit Questionnaire response: The agency has a written policy that limits its ability to discipline a resident for filing a grievance alleging sexual abuse to occasions where the agency demonstrates that the resident filed the grievance in bad faith.

- **115.353** (a) Acadiana Center for Youth at St. Martinville Pre-Audit Questionnaire response: The facility provides residents access to outside victim advocates for emotional support services related to sexual abuse by:
- Giving residents (by providing, posting, or otherwise making accessible) mailing addresses and telephone numbers (including toll-free hotline numbers where

available) of local, State, or national victim advocacy or rape crisis organizations.

• Enabling reasonable communication between residents and these organizations, in as confidential a manner as possible.

Louisiana Office of Juvenile Justice PREA Manual, 6th edition, dated 2023, page 26, section VII.C.1, states each facility shall provide youth with access to outside victim advocates for emotional support services related to sexual abuse, by providing, posting, or otherwise making accessible mailing addresses and telephone numbers, including toll free hotline numbers where available, of local, state, or national victim advocacy or rape crisis organizations. The facility shall enable reasonable communication between youths and these organizations and agencies, in as confidential a manner as possible.

The PREA Coordinator confirmed juveniles are not detained solely for civil immigration purposes.

The auditor observed the "No Means No" poster included contact information for outside victim advocate services for emotional support related to sexual abuse through STAR. Posters are located throughout the facility, including next to the telephones. The posters are in English and Spanish. The posters were in a large font and not obscured by graffiti or damaged.

The auditor tested the telephones. The auditor called STAR and was informed the facility was out of the agency's service area. The auditor contacted the STAR President & CEO and confirmed STAR does not serve St. Martin Parish. The advocacy organization that serves St. Martin Parish is Hearts of Hope. Through corrective action, the agency developed a memorandum of understanding between the Louisiana Office of Juvenile Justice and Hearts of Hope effective May 28, 2024. The "No Means No" poster was updated July 26, 2024, to reflect Hearts of Hope provides victim advocate services for emotional support related to sexual abuse.

**115.353 (b)** Acadiana Center for Youth at St. Martinville Pre-Audit Questionnaire response: The facility informs residents, prior to giving them access to outside support services, the extent to which such communications will be monitored. The facility informs residents, prior to giving them access to outside support services, of the mandatory reporting rules governing privacy, confidentiality, and/or privilege that apply to disclosures of sexual abuse made to outside victim advocates, including any limits to confidentiality under relevant Federal, State, or local law.

Louisiana Office of Juvenile Justice PREA Manual, 6th edition, dated 2023, page 26, section VII.C.2, states the facility shall inform youths, prior to giving them access, of the extent to which such communications will be monitored and the extent to which reports of abuse will be forwarded to authorities in accordance with mandatory reporting laws.

The auditor observed the "No Means No" poster includes information about the extent to which such communications will be monitored and related mandatory reporting requirements.

**115.353 (c)** Acadiana Center for Youth at St. Martinville Pre-Audit Questionnaire response: The agency or facility maintains memoranda of understanding (MOUs) or other agreements with community service providers that are able to provide residents with emotional support services related to sexual abuse. The agency or facility maintains copies of those agreements.

Louisiana Office of Juvenile Justice PREA Manual, 6th edition, dated 2023, page 26, section VII.C.3, states the Agency shall maintain or attempt to enter into memoranda of understanding or other agreements with community service providers that are able to provide youths with confidential emotional support services related to sexual abuse. The Agency shall maintain copies of agreements or documentation showing attempts to enter into such agreements.

The auditor reviewed the unsigned and undated memorandum of understanding with STAR. Through corrective action, the agency developed a memorandum of understanding between the Louisiana Office of Juvenile Justice and Hearts of Hope effective May 28, 2024.

**115.353 (d)** Acadiana Center for Youth at St. Martinville Pre-Audit Questionnaire response: The facility provides residents with reasonable and confidential access to their attorneys or other legal representation. The facility provides residents with reasonable access to parents or legal guardians.

Louisiana Office of Juvenile Justice PREA Manual, 6th edition, dated 2023, page 26, section VII.C.4, states the facility shall also provide youth with reasonable and confidential access to their attorneys or other legal representative and reasonable access to parents or legal guardians.

The Facility Director and PREA Compliance Manager confirmed the facility would provide residents with reasonable and confidential access to their attorneys or other legal representation and reasonable access to parents or legal guardians. Residents confirmed the facility allows them to see or talk with their lawyer or another lawyer and they are allowed to talk with that person privately. Residents also confirmed the facility allows them to see or talk with their parents or someone else such as a legal guardian.

**Conclusion Corrective Action:** Based upon the review and analysis of the available evidence, the auditor has determined the facility is fully compliant with this standard regarding resident access to outside confidential support services and legal representation. Corrective action is complete.

The website includes the following instructions, "All reports of sexual abuse or sexual harassment will be investigated and addressed. Youth, employees, and third parties can report incidents of sexual abuse or sexual harassment in verbal or written formats. All parties can file a report with the Office of Juvenile Justice by calling the Investigative Services hotline at 1-800-626-1430. Reporters can remain anonymous or provide contact information in the event more information is needed."

The auditor tested third-party reporting by calling the number provided. The call was responded to the same day. In addition to the published information on the agency website, the auditor observed contact information for third-party reporting is available on posters located throughout the facility. The auditor observed posters in English and Spanish. The auditor observed the calling instructions for the Investigative Services hotline were not accurate. Through corrective action, the

posters were updated to include accurate calling instructions (3/12/2024). Pictures of the posters were provided to the auditor for verification the changes were made, and the updated posters have been posted.

**Conclusion and Corrective Action:** Based upon the review and analysis of the available evidence, the auditor has determined the facility is fully compliant with this standard regarding third-party reporting. Corrective action is complete.

The posters were updated to include accurate calling directions to the Investigative Services hotline (3/12/2024).

- Any knowledge, suspicion, or information they receive regarding an incident of sexual abuse or sexual harassment that occurred in a facility, whether or not it is part of the agency.
- Any retaliation against residents or staff who reported such an incident.
- Any staff neglect or violation of responsibilities that may have contributed to an incident or retaliation.

Louisiana Office of Juvenile Justice PREA Manual, 6th edition, dated 2023, pages

27-28, section VIII.A.1-8, states all staff shall report immediately any knowledge, suspicion, or information they receive regarding an incident of sexual abuse or sexual harassment that occurred in a facility, whether or not it is a part of the Agency pursuant to YS Policy No. C.4.3. Staff receiving reports of sexual assault or sexual harassment shall immediately contact his/her supervisor/manager and in the case of a contract program, the supervising PPO/J. Staff may also use the IS Hotline by calling 1-800-626-1430 to report the incident. Staff shall report retaliation against youth or staff who reported such an incident of sexual abuse or sexual harassment; and any staff neglect or violation of responsibilities that may have contributed to an incident or retaliation.

Interviews with staff confirmed the requirement to report any knowledge, suspicion, or information they receive regarding an incident of sexual abuse or sexual harassment that occurred in a facility, whether or not it is part of the agency; retaliation against residents or staff who reported such an incident; and any staff neglect or violation of responsibilities that may have contributed to an incident or retaliation.

**115.361 (b)** Acadiana Center for Youth at St. Martinville Pre-Audit Questionnaire response: The agency requires all staff to comply with any applicable mandatory child abuse reporting laws.

Louisiana Office of Juvenile Justice PREA Manual, 6th edition, dated 2023, page 28, section VIII.A.9, states all staff shall comply with mandatory child abuse reporting laws pursuant to YS Policy No. C.4.3, and Federal and State Law. Failure of staff to report sexual abuse and sexual harassment and/or comply with Mandatory Reporting provisions above shall result in disciplinary action.

Interviews with staff confirmed they are knowledgeable of mandatory child abuse reporting laws. Staff reported they would report to their direct supervisor.

**115.361 (c)** Acadiana Center for Youth at St. Martinville Pre-Audit Questionnaire response: Apart from reporting to designated supervisors or officials and designated State or local service agencies, agency policy prohibits staff from revealing any information related to a sexual abuse report to anyone other than to the extent necessary to make treatment, investigation, and other security and management decisions.

Louisiana Office of Juvenile Justice PREA Manual, 6th edition, dated 2023, page 28, section VIII.A.11, states except for reporting to supervisors, Facility Directors, Central Office management, and designated State or local services agencies as provided for in YS Policy No. C.4.3, staff are prohibited from revealing any information related to a sexual abuse report to anyone other than to the extent necessary, to make treatment, investigation, and other security and management decisions.

Staff interviewed were knowledgeable that OJJ policy prohibits them from revealing any information related to a sexual abuse report to anyone other than to the extent necessary to make treatment, investigation, and other security and management

decisions.

**115.361 (d)** Louisiana Office of Juvenile Justice PREA Manual, 6th edition, dated 2023, page 28, section VIII.A.12, states medical and mental health practitioners shall report sexual abuse in accordance with contract provisions and mandatory child abuse reporting laws. Such practitioners shall be required to inform youths at the initiation of services of their duty to report and the limitations of confidentiality.

Interviews with Health Services Administrator and Mental Health Coordinator confirmed they disclose the limitations of confidentiality and their duty to report, at the initiation of services to a resident. They confirmed they are mandated to report any knowledge, suspicion, or information regarding an incident of sexual abuse or sexual harassment. They both stated they have not become aware of such incidents.

**115.361 (e)** Louisiana Office of Juvenile Justice PREA Manual, 6th edition, dated 2023, page 29, section VIII.A.14, states if the alleged victim is under the guardianship of the child welfare system, the report shall be made to the alleged victim's caseworker instead of the parents or legal guardians. The Facility Director shall also report the allegation to the appropriate juvenile judge, the juvenile's attorney, or other legal representative of record within 14 days of receiving the allegation.

The Facility Director stated she would report allegations of sexual abuse to IS and the parents or legal guardians would be notified. If the victim is under the guardianship of the Louisiana Department of Children and Family Services (DCFS), she stated she would report the allegation to a victim's caseworker instead of the parents or legal guardians. She confirmed if a juvenile court retains jurisdiction over a victim the victim's attorney would be contacted within 24 hours.

The PREA Compliance Manager stated when the facility receives an allegation of sexual abuse, she reports the allegation to central office and the youth's parents or guardian. If the victim is under the guardianship of the Louisiana Department of Children and Family Services, she stated the allegation would be reported to the probation officer. Notifications would be made immediately. Lastly, she stated if a juvenile court retains jurisdiction over a victim, the allegation would be reported to the juvenile's attorney or other legal representative of record. She stated they would be notified within 14 days.

**115.361 (f)** Louisiana Office of Juvenile Justice PREA Manual, 6th edition, dated 2023, page 27, section VIII.A.4-5, states upon receiving any allegation of sexual abuse or sexual harassment, including third-party and anonymous complaints, the Facility Director/Regional Manager shall promptly report the allegation to the appropriate Regional Director, PREA Compliance Manager and the Director of IS. If the sexual abuse or sexual harassment occurs in a secure facility, the Facility Director shall also notify the Regional Manager from the youth's region of origin. The Facility Director shall also notify the assigned Probation and Parole Officer, the alleged victim's parents, or legal guardians, unless the facility has official documentation showing the parents or legal guardians should not be notified.

Pursuant to YS Policy No. C.2.6 and facility SOPs, secure care facility staff shall initiate a UOR [refer to YS Policy No. C.2.6 (b)], and notify a facility IS Investigator, or if unavailable a Central Office supervisory investigator. Law enforcement is to be notified as appropriate and in accordance with local procedures.

The Facility Director confirmed all allegations of sexual abuse and sexual harassment (including those from third-party and anonymous sources) are reported to investigative services.

**Conclusion:** Based upon the review and analysis of the available evidence, the auditor has determined the facility is fully compliant with this standard regarding staff and agency reporting duties. No corrective action is required.

The Deputy Secretary confirmed immediate actions will be taken to protect a resident who is subject to a substantial risk of imminent sexual abuse. Protective measures would include increasing staffing, housing changes or transfers. The Facility Director confirmed when she learns that a resident is subject to a substantial risk of imminent sexual abuse, the facility would take immediate protective actions such as remove the individual from the area and providing mental health treatment. Additionally, a pod change may occur. Staff confirmed they would take immediate actions such as removing a resident from potential harm and providing close observation.

**Conclusion:** Based upon the review and analysis of the available evidence, the auditor has determined the facility is fully compliant with this standard regarding agency protection duties. No corrective action is required.

Louisiana Office of Juvenile Justice PREA Manual, 6th edition, dated 2023, page 30, section VIII.F.1, states no collective bargaining agreement or other agreement can be entered into that would limit the Agency's ability to remove alleged staff sexual abusers from contact with youth pending the outcome of an investigation or of a determination of whether and to what extent discipline is warranted.

The Deputy Secretary confirmed the Louisiana Office of Juvenile Justice does not have a collective bargaining agreement or any form of employee union that limits the agency's ability to remove alleged staff sexual abusers from contact with residents pending the outcome of an investigation or of a determination of whether and to what extent discipline is warranted.

115.366 (b) Louisiana Office of Juvenile Justice PREA Manual, 6th edition, dated

2023, page 31, section VIII.F.2.a-b, states Nothing shall restrict the entering into or renewal of agreements that govern:

- a. The conduct of the disciplinary process, as long as such agreements are not inconsistent with the provisions of this policy regarding evidentiary standards for administrative proceeding.
- b. Whether a no-contact assignment that is imposed pending the outcome of an investigation shall be expunged from or retained in the staff member's personnel file following a determination that the allegation of sexual abuse is not substantiated.

The Deputy Secretary confirmed the Louisiana Office of Juvenile Justice does not have a collective bargaining agreement that limits the agency's ability to remove alleged staff sexual abusers from contact with residents pending the outcome of an investigation or of a determination of whether and to what extent discipline is warranted.

**Conclusion:** Based upon the review and analysis of the available evidence, the auditor has determined the facility is fully compliant with this standard regarding the preservation of ability to protect residents from contact with abusers. No corrective action is required.

# **Findings (By Provision):**

**115.367 (a)** Acadiana Center for Youth at St. Martinville Pre-Audit Questionnaire response: The agency has a policy to protect all residents and staff who report sexual abuse or sexual harassment or cooperate with sexual abuse or sexual harassment investigations from retaliation by other residents or staff.

The agency has designated Social Services, with monitoring for possible retaliation.

Louisiana Office of Juvenile Justice PREA Manual, 6th edition, dated 2023, page 31, section VIII.G.1, states youth and staff who report sexual abuse or sexual harassment or cooperate with sexual abuse or sexual harassment investigations shall be protected from retaliation by other youth or staff.

**115.367 (b)** Louisiana Office of Juvenile Justice PREA Manual, 6th edition, dated 2023, page 31, section VIII.G.2, states Multiple protection measures shall be employed, such as housing changes or transfers for youth victims or abusers, removal of alleged staff or youth abusers from contact with victims, and emotional support services for youth or staff that fear retaliation for reporting sexual abuse or sexual harassment or for cooperating with investigations.

The Deputy Secretary confirmed the facility would protect residents and staff from retaliation for sexual abuse and sexual harassment allegations thorough housing changes or transfers and retaliation monitoring. The Facility Director explained different measures taken to protect residents and staff from retaliation. The facility encourages reporting, pod changes may occur, shift changes for staff may be made, and mental health and medical services are provide as needed.

The designated staff member charged with monitoring retaliation (Social Services Supervisor) stated the role she plays in preventing retaliation against residents and staff who report sexual abuse or sexual harassment, or against those who cooperate with sexual abuse or sexual harassment investigations. Housing changes or transfers would be made, alleged abusers would be removed, and emotional support services would be provided. The different measures taken to protect those residents and staff from retaliation include meeting with staff and residents to have proactive conversations, separation, and pod changes. She confirmed she would initiate contact with residents who have reported sexual abuse weekly.

There were no residents, who reported a sexual abuse, identified during the onsite phase of the audit.

- **115.367 (c)** Acadiana Center for Youth at St. Martinville Pre-Audit Questionnaire response: The agency and/or facility monitors the conduct or treatment of residents or staff who reported sexual abuse and of residents who were reported to have suffered sexual abuse to see if there are any changes that may suggest possible retaliation by residents or staff.
- The length of time that the agency and/or facility monitors the conduct or treatment: 90 days
- The agency/facility acts promptly to remedy any such retaliation. The agency/facility continues such monitoring beyond 90 days if the initial monitoring indicates

a continuing need.

• The number of times an incident of retaliation occurred in the past 12 months: 0

Louisiana Office of Juvenile Justice PREA Manual, 6th edition, dated 2023, pages 31-32, section VIII.G.3.a-f, states for at least 90 days following a report of sexual abuse, the Agency shall monitor the conduct or treatment of youth or staff who reported the sexual abuse, and of youth who were reported to have suffered sexual abuse to see if there are changes that may suggest possible retaliation by youth or staff and shall act promptly to remedy any such retaliation. Monitoring by IS shall include:

- a. Review of UORs;
- b. Youth violation reports;
- c. Housing or Program changes of relevant youth;
- d. Negative performance reviews or reassignments of pertinent staff;
- e. Periodic status checks of youth; and
- f. Follow up discussions with youth reports and victims of sexual assault, staff reporters, housing unit and treatment staff.

Monitoring shall be documented in the IS case file by completing the Protection Against Retaliation Form for the appropriate staff/youth for each PREA related incident, pursuant to established procedures in YS Policy No. A.1.4, Investigative Services Handbook. The Agency shall continue such monitoring beyond 90 days if the initial monitoring indicates a continuing need.

The Social Services Supervisor explained what she looks for to detect possible retaliation would include behaviors such as changes in mood, bullying, and withdrawal. She would monitor dorm changes and transfers. She would monitor the conduct and treatment of residents and staff who report the sexual abuse of a resident or were reported to have suffered sexual abuse for 90 days. If there is concern that potential retaliation might occur, the maximum length of time that he would monitor conduct and treatment would be for as long as needed. The Facility Director confirmed if retaliation is suspected, the person alleging retaliation would be met with and individuals would be removed to inhibit their ability to retaliate.

**115.367 (d)** Louisiana Office of Juvenile Justice PREA Manual, 6th edition, dated 2023, page 31, section VIII.G.3.e, states monitoring by IS shall include: Periodic status checks of youth

The Social Services Supervisor confirmed the Protections Against Retaliation Monitoring form would be used for periodic status checks of youth. The auditor observed the form documents weekly status checks.

The auditor observed the Louisiana Office of Juvenile Justice, Form A.1.4.e: Protections Against Retaliation Form for Reporters of Sexual Abuse dated February 2024, is used to document monitoring retaliation for allegations of sexual abuse and sexual harassment.

During the 12-month audit period there were no allegations of sexual abuse or sexual harassment, with the exception of one allegation pending investigation.

**115.367 (e)** Louisiana Office of Juvenile Justice PREA Manual, 6th edition, dated 2023, page 32, section VIII.G.4, states If any other individual who cooperates with an investigation expresses a fear of retaliation, the Agency shall take appropriate measures to protect that individual against retaliation.

The Deputy Secretary confirmed the facility would protect residents and staff from retaliation for sexual abuse and sexual harassment allegations thorough housing changes or transfers and retaliation monitoring. The Facility Director stated if an individual who cooperates with an investigation expresses a fear of retaliation different measures taken would include pod changes, shift changes for staff, and mental health and medical services are provided as needed.

**115.367 (f)** Louisiana Office of Juvenile Justice PREA Manual, 6th edition, dated 2023, page 31, section VIII.G.5, states the Agency's obligation to monitor shall terminate if IS determines that the allegation is unfounded. The auditor reviewed OJJ policy and confirmed the facility follows this standard provision.

**Conclusion:** Based upon the review and analysis of the available evidence, the auditor has determined the facility is fully compliant with this standard regarding agency protection against retaliation. No corrective action is required.

# Findings (By Provision):

**115.371 (a)** Acadiana Center for Youth at St. Martinville Pre-Audit Questionnaire response: The agency/facility has a policy related to criminal and administrative agency investigations. The PAQ indicates DYS uses the term internal inquiry in policy instead of investigation.

Louisiana Office of Juvenile Justice PREA Manual, 6th edition, dated 2023, page 32, section IX.A.1, states IS conducted investigations into allegations of sexual abuse and sexual harassment shall be done promptly, thoroughly, and objectively for all allegations, including third-party and anonymous reports pursuant to YS Policy No. A.1.4.

The investigator confirmed allegations of sexual abuse and sexual harassment are initiated immediately upon notification of an incident. Anonymous or third-party

reports of sexual abuse and sexual harassment are conducted in the same manner as all investigations.

The auditor reviewed 1 incident report for a pending investigation of a potential allegation of resident-on-resident sexual abuse or sexual harassment.

**115.371 (b)** Louisiana Office of Juvenile Justice PREA Manual, 6th edition, dated 2023, pages 32-33, section IX.A.3, states where sexual abuse is alleged, the Agency shall use investigators who have received special training in sexual abuse investigations involving juvenile victims.

The auditor reviewed annual training required by §115.331 and NIC certificates for PREA: Investigating Sexual Abuse in a Confinement Setting and Advanced investigations. The training was completed by the Louisiana Office of Juvenile Justice Department of Investigative Services investigator. An interview with the Investigator confirmed he has received the required training.

**115.371 (c)** Louisiana Office of Juvenile Justice PREA Manual, 6th edition, dated 2023, page 33, section IX.A.4, states investigators shall gather and preserve direct and circumstantial evidence, including any available physical and DNA evidence and any available electronic monitoring data; shall interview alleged victims, suspected perpetrators, and witnesses; and shall review prior complaints and reports of sexual abuse involving the suspected perpetrator.

The investigator confirmed the first steps in initiating an investigation are receipt of the allegation, gathering information, and beginning the investigation. The investigation process includes conducting interviews and reviewing all documents available. Direct and circumstantial evidence he would be responsible for gathering in an investigation of an incident of sexual abuse includes include clothing, possible DNA evidence, video, and interviews, statements, pictures, medical records, etc.

**115.371 (d)** Acadiana Center for Youth at St. Martinville Pre-Audit Questionnaire response: The agency does not terminate an investigation solely because the source of the allegation recants the allegation.

Louisiana Office of Juvenile Justice PREA Manual, 6th edition, dated 2023, page 33, section IX.A.5, states the Agency shall not terminate an investigation solely because the source of the allegation recants the allegation.

The investigator confirmed an investigation would not be terminated solely because the source of the allegation recants the allegation.

**115.371 (e)** Louisiana Office of Juvenile Justice PREA Manual, 6th edition, dated 2023, page 33, section IX.A.6, states when the quality of evidence appears to support criminal prosecution, the Agency shall conduct compelled interviews, only after consulting with prosecutors as to whether compelled interviews may be an obstacle for subsequent criminal prosecution as appropriate.

The investigator confirmed compelled interviews would not be conducted until after an administrative investigation.

**115.371 (f)** Louisiana Office of Juvenile Justice PREA Manual, 6th edition, dated 2023, page 33, section IX.A.7, states the credibility of an alleged victim, suspect, or witness shall be assessed on an individual basis and shall not be determined by the person's status as youth or staff. A youth who alleges sexual abuse shall not be compelled to submit to a polygraph examination or other truth-telling device as a condition for proceeding with the investigation of such an allegation.

The investigator confirmed that under no circumstances would an investigator require a resident who alleges sexual abuse to submit to a polygraph examination or truth telling device as a condition for proceeding with an investigation.

**115.371 (g)** Louisiana Office of Juvenile Justice PREA Manual, 6th edition, dated 2023, page 33, section IX.A.8.a-b, states administrative investigations shall include an effort to determine whether staff actions or failures to act contributed to the abuse; and shall be documented in written reports that include a description of the physical and testimonial evidence, the reasoning behind credibility assessments, and investigative facts and findings.

The investigator confirmed staff actions or failures to act that contributed to sexual abuse are considered in investigations. Administrative investigations are documented in written reports that include the parties involved, the time of the incident, location, and witness statements.

**115.371 (h)** Louisiana Office of Juvenile Justice PREA Manual, 6th edition, dated 2023, page 33, section IX.A.9, states criminal investigations shall be documented in a written report that contains a thorough description of physical, testimonial, and documentary evidence and attaches copies of all documentary evidence where feasible.

The Investigator confirmed criminal investigations are documented. The reports include the parties involved, the time of the incident, location, and witness statements.

**115.371 (i)** Acadiana Center for Youth at St. Martinville Pre-Audit Questionnaire response: Substantiated allegations of conduct that appear to be criminal are referred for prosecution.

The number of substantiated allegations of conduct that appear to be criminal that were referred for prosecution since the last PREA audit: 0

Louisiana Office of Juvenile Justice PREA Manual, 6th edition, dated 2023, page 33, section IX.A.10, states substantiated allegations of conduct that appears to be criminal shall be referred for prosecution.

The investigator confirmed substantiated allegations of conduct that appears to be criminal are referred for prosecution when the conduct appears to be criminal.

**115.371 (j)** Acadiana Center for Youth at St. Martinville Pre-Audit Questionnaire response: The agency retains all written reports pertaining to the administrative or criminal investigation of alleged sexual abuse or sexual harassment for as long as

the alleged abuser is incarcerated or employed by the agency, plus five years.

Louisiana Office of Juvenile Justice PREA Manual, 6th edition, dated 2023, pages 33-34, section IX.A.11, states the Agency shall retain all written reports referenced in subparagraphs 8 and 9 of this section for as long as the alleged abuser is incarcerated or employed by the Agency, plus five (5) years, unless the abuse was committed by a youth and applicable law requires a shorter period of retention.

**115.371 (k)** Louisiana Office of Juvenile Justice PREA Manual, 6th edition, dated 2023, page 34, section IX.A.12, states the departure of the alleged abuser or victim from the employment or control of the facility or Agency shall not provide a basis for terminating an investigation.

The Investigator confirmed investigators continue to conduct investigations when a staff member alleged to have committed sexual abuse or sexual harassment terminates employment prior to a completed investigation into his/her conduct.

**115.371 (m)** Louisiana Office of Juvenile Justice PREA Manual, 6th edition, dated 2023, page 34, section IX.A.13, states when outside agencies investigate sexual abuse, the facility shall cooperate with outside investigators and shall endeavor to remain informed about the progress of the investigation.

The investigator, Facility Director, PREA Coordinator, and PREA Compliance Manager confirmed Acadiana Center for Youth at St. Martinville would cooperate with outside investigators and would remain informed about the progress of the investigation. The investigator stated he would assist as needed.

**Conclusion:** Based upon the review and analysis of the available evidence, the auditor has determined the facility is fully compliant with this standard regarding criminal and administrative agency investigations. No corrective action is required.

The Investigator confirmed a preponderance of evidence is required to substantiate allegations of sexual abuse or sexual harassment.

**Conclusion:** Based upon the review and analysis of the available evidence, the auditor has determined the facility is fully compliant with this standard regarding evidentiary standard for administrative investigations. No corrective action is required.

**115.373** (a) Acadiana Center for Youth at St. Martinville Pre-Audit Questionnaire response: The agency has a policy requiring that any resident who makes an allegation that he or he suffered sexual abuse in an agency facility is informed, verbally or in writing, as to whether the allegation has been determined to be

substantiated, unsubstantiated, or unfounded following an investigation by the agency.

# In the past 12 months:

The number of criminal and/or administrative investigations of alleged resident sexual abuse that were completed by the agency/facility: 0 Of the investigations that were completed of alleged sexual abuse, the number of residents who were notified, verbally or in writing, of the results of the investigation: 1 (This entry was revised to 0.)

Louisiana Office of Juvenile Justice PREA Manual, 6th edition, dated 2023, page 34, section IX.C, states following an investigation into a youth's allegation of sexual abuse in a secure facility, IS shall inform the youth as to whether the allegation has been substantiated, unsubstantiated or unfounded. IS shall generate a "Youth Letter" through the Central Registry Database and distribute the letter to the appropriate Program Manager of the youth's assigned facility. The Program Manager or designee shall ensure that the youth receives a copy of the "Youth Letter" and that a copy of the letter with the youth's signature is placed in the youth's file. The assigned investigator shall place a copy of the "Youth Letter" in the investigative case file, along with receipts that this distribution took place.

The Facility Director stated the facility notifies a resident who makes an allegation of sexual abuse, that the allegation has been determined to be substantiated, unsubstantiated, or unfounded. The Investigator confirmed when a resident makes an allegation of sexual abuse, the resident will be informed as to whether the allegation has been determined to be substantiated, unsubstantiated, or unfounded following an investigation.

The auditor observed the Juvenile Notification of Investigative Outcome Form is inclusive of the standard provision requirements. The form informs residents, in writing, as to whether an allegation has been determined to be substantiated, unsubstantiated, or unfounded following an investigation by the agency.

**115.373 (b)** Acadiana Center for Youth at St. Martinville Pre-Audit Questionnaire response: If an outside entity conducts such investigations, the agency requests the relevant information from the investigative entity in order to inform the resident of the outcome of the investigation.

- **115.373 (c)** Acadiana Center for Youth at St. Martinville Pre-Audit Questionnaire response: Following a resident's allegation that a staff member has committed sexual abuse against the resident, the agency/facility subsequently informs the resident (unless the agency/facility has determined that the allegation is unfounded) whenever:
- The staff member is no longer posted within the resident's unit; The staff member is no longer employed at the facility;
- The agency learns that the staff member has been indicted on a charge related to sexual abuse within the facility; or
- The agency learns that the staff member has been convicted on a charge related to sexual abuse within the facility.

There has not been a substantiated or unsubstantiated complaint (i.e., not unfounded) of sexual abuse committed by a staff member against a resident in the past 12 months.

Louisiana Office of Juvenile Justice PREA Manual, 6th edition, dated 2023, pages 34-35, section IX.C.3.a-d, states following a youth's allegation that a staff member has sexually abused the youth, IS shall inform the youth (except where IS has found the allegation to be unfounded) whenever:

- a. The staff member is no longer posted within the youth's unit;
- b. The staff member is no longer employed at the facility;
- c. The Agency learns that the staff member has been indicted on a charge related to sexual
- d. The Agency learns that the staff member has been convicted on a charge related to sexual abuse within the facility.

The auditor observed the Juvenile Notification of Investigative Outcome Form is inclusive of the standard provision requirement of informing residents when a staff member is no longer posted on the youth's unit, is no longer employed at the facility, and when indicted and convicted on a charge related to sexual abuse within the facility.

**115.373 (d)** Acadiana Center for Youth at St. Martinville Pre-Audit Questionnaire response: Following a resident's allegation that he or she has been sexually abused by another resident in an agency facility, the agency subsequently informs the alleged victim whenever:

The agency learns that the alleged abuser has been indicted on a charge related to sexual abuse within the facility; or The agency learns that the alleged abuser has been convicted on a charge related to sexual abuse within the facility.

Louisiana Office of Juvenile Justice PREA Manual, 6th edition, dated 2023, page 35, section IX.C.4.a-b, states following a youth's allegation that he or she has been sexually abused by another youth, IS shall inform the alleged victim whenever:

- a. The Agency learns that the alleged abuser has been indicted on a charge related to sexual abuse within the facility; or
- b. The Agency learns that the alleged abuser has been convicted on a charge related to sexual abuse within the facility.

The auditor observed the Juvenile Notification of Investigative Outcome Form is inclusive of the standard provision requirement of informing residents when an alleged abuser is indicted and convicted on a charge related to sexual abuse within the facility.

Agency policy requires that any contractor or volunteer who engages in sexual abuse be prohibited from contact with residents.

In the past 12 months, no contractors or volunteers have been reported to law enforcement agencies and relevant licensing bodies for engaging in sexual abuse of residents.

Louisiana Office of Juvenile Justice PREA Manual, 6th edition, dated 2023, page 38, section XI.B.1, states any contractor or volunteer who engages in sexual abuse at a minimum shall be prohibited from contact with youths and shall be reported to law enforcement agencies, unless the activity was clearly not criminal, and to relevant licensing bodies.

**115.377 (b)** Acadiana Center for Youth at St. Martinville Pre-Audit Questionnaire response: The facility takes appropriate remedial measures and considers whether to prohibit further contact with residents in the case of any other violation of agency

sexual abuse or sexual harassment policies by a contractor or volunteer.

Louisiana Office of Juvenile Justice PREA Manual, 6th edition, dated 2023, page 38, section XI.C.1, states pursuant to YS Policy No. B.5.1, a youth may be subject to disciplinary sanctions only pursuant to a formal disciplinary process following an administrative finding that the youth engaged in youth-on-youth sexual abuse or following a criminal finding of guilt for youth-on-youth sexual abuse.

**115.378 (b)** Acadiana Center for Youth at St. Martinville Pre-Audit Questionnaire response: In the event a disciplinary sanction for resident-on resident sexual abuse results in the isolation of a resident, the facility policy requires that residents in isolation have daily access to large muscle exercise, legally required educational programming, and special education services. In the event a disciplinary sanction for resident-on resident sexual abuse results in the isolation of a resident, residents in isolation receive daily visits from a medical or mental health care clinician. In the event a disciplinary sanction for resident-on resident sexual abuse results in the isolation of a resident, residents in isolation have access to other programs and work opportunities to the extent possible.

Youth in BI shall receive daily visits from a medical or mental health care clinician. Youths shall also have access to other programs and work opportunities to the extent possible. BI paperwork must be completed as per YS Policy B.2.21.

The Facility Director confirmed isolation is not used as a disciplinary sanction for resident-on resident sexual abuse.

**115.378 (c)** Louisiana Office of Juvenile Justice PREA Manual, 6th edition, dated 2023, page 38, section XI.C.4, states the disciplinary process shall consider whether a youth's mental disabilities or mental illness contributed to his or her behavior when determining what type of sanction, if any, should be imposed.

The Facility Director confirmed mental disability or mental illness is considered when determining sanctions.

**115.378 (d)** Acadiana Center for Youth at St. Martinville Pre-Audit Questionnaire response: The facility offers therapy, counseling, or other interventions designed to address and correct the underlying reasons or motivations for abuse. If the facility offers therapy, counseling, or other interventions designed to address and correct the underlying reasons or motivations for abuse, the facility considers whether to require the offending resident to participate in such interventions as a condition of access to any rewards-based behavior management system or other behavior-based incentives. Access to general programming or education is not conditional on participation in such interventions.

Louisiana Office of Juvenile Justice PREA Manual, 6th edition, dated 2023, pages 38-39, section XI.C.5, states the facility shall consider whether to offer the offending youth participation in such therapy, counseling or other interventions designed to address and correct underlying reasons or motivations for the abuse. Participation in such interventions may be required as a condition of access to any rewards-based behavior management system or other behavior-based incentives, but not as a condition to access to general programming or education.

The Mental Health Professional confirmed if the facility offers therapy, counseling, or other intervention services designed to address and correct the underlying reasons or motivations for sexual abuse to an offending resident, a resident's participation is not a condition of access to any rewards-based behavior management system or programming or education.

**115.378 (e)** Acadiana Center for Youth at St. Martinville Pre-Audit Questionnaire response: The agency disciplines residents for sexual contact with staff only upon finding that the staff member did not consent to such contact.

Louisiana Office of Juvenile Justice PREA Manual, 6th edition, dated 2023, page 39, section XI.C.6, states the Agency may discipline a youth for sexual contact with staff only upon a finding that the staff member did not consent to such contact.

**115.378 (f)** Acadiana Center for Youth at St. Martinville Pre-Audit Questionnaire response: The agency prohibits disciplinary action for a report of sexual abuse made in good faith based upon a reasonable belief that the alleged conduct occurred, even if an investigation does not establish evidence sufficient to substantiate the allegation.

Louisiana Office of Juvenile Justice PREA Manual, 6th edition, dated 2023, page 39, section XI.C.7, states for the purpose of disciplinary action, a report of sexual abuse made in good faith based upon a reasonable belief that the alleged conduct

occurred shall not constitute falsely reporting an incident or lying, even if an investigation does not establish evidence sufficient to substantiate the allegation.

**115.378 (g)** Acadiana Center for Youth at St. Martinville Pre-Audit Questionnaire response: The agency prohibits all sexual activity between residents. The agency deems such activity to constitute sexual abuse only if it determines that the activity is coerced.

Louisiana Office of Juvenile Justice PREA Manual, 6th edition, dated 2023, page 39, section XI.C.8, states all sexual activity between youths is prohibited. The Agency may, at its discretion, discipline youths for such activity. However, such activity shall not be deemed to constitute sexual abuse if it determines that the activity is not coerced.

**115.381 (a)** Acadiana Center for Youth at St. Martinville Pre-Audit Questionnaire response: All residents at this facility who have disclosed any prior sexual victimization during a screening pursuant to §115.341 are offered a follow-up meeting with a medical or mental health practitioner. The follow-up meeting was offered within 14 days of the intake screening. Medical and mental health staff maintain secondary materials (e.g., form, log) documenting compliance with the above required services.

In the past 12 months, the number of residents who disclosed prior victimization during screening who were offered a follow up meeting with a medical or mental health practitioner: 0 (Interviews with residents revealed this assertion is not accurate.)

Louisiana Office of Juvenile Justice PREA Manual, 6th edition, dated 2023, page 39, section XII.A.1, states if the screening indicates that a youth has experienced prior sexual victimization, whether it occurred in an institutional setting or in the community, staff shall ensure that the youth is offered a follow-up meeting with a medical or mental health practitioner within 14 days of the direct admission screening.

The Staff Responsible for Risk Screening (Social Services Supervisor) confirmed if a screening indicates that a resident has experienced prior sexual victimization, whether in an institutional setting, or in the community, they are offered a follow-up meeting with a medical/and or mental health practitioner within 14 days.

The auditor interviewed 6 residents who were identified as disclosing any prior sexual victimization during a screening. Five of the 6 residents confirmed they were offered a follow-up meeting with a mental health practitioner within 14 days of admission to the facility. Two residents stated they accepted the follow-up meeting, one resident stated she had a court ordered therapist, and 2 residents state they declined the follow-up meeting. One resident stated she did not remember.

The auditor requested documented follow-up meetings for residents who disclosed prior sexual victimization, for residents interviewed and historical documentation for the 12-month audit period. Through corrective action, the facility provided a statement and one applicable follow-up meeting for a resident who disclosed prior sexual victimization October 7, 2024. The auditor observed the follow-up meeting occurred within 14 days of risk screening.

**115.381 (b)** Acadiana Center for Youth at St. Martinville Pre-Audit Questionnaire response: All residents who have previously perpetrated sexual abuse, as indicated during the screening pursuant to § 115.341, are offered a follow-up meeting with a mental health practitioner. The follow-up meeting was offered within 14 days of the intake screening. Mental health staff maintain secondary materials (e.g., form, log) documenting compliance with the above required services.

In the past 12 months, the number of residents who previously perpetrated sexual abuse, as indicated during screening, who were offered a follow up meeting with a

mental health practitioner: 0 (Interviews with residents revealed this assertion is not accurate.)

Louisiana Office of Juvenile Justice PREA Manual, 6th edition, dated 2023, page 39, section XII.A.2, states if the screening indicates that a youth has previously perpetrated sexual abuse, whether it occurred in an institutional setting or in the community, staff shall ensure that the youth is offered a follow-up meeting with a mental health practitioner within 14 days of the direct admission screening.

The Social Services Supervisor confirmed if a screening indicates that a resident has previously perpetrated sexual abuse, whether in an institutional setting, or in the community, they are offered a follow-up meeting with a medical/and or mental health practitioner within 14 days.

During the onsite phase of the audit the facility identified no residents who previously perpetrated sexual abuse.

The auditor requested documented follow-up meetings for residents who previously perpetrated sexual abuse, for residents interviewed and historical documentation for the 12-month audit period. The facility provided a statement that indicated there were no residents who disclosed previously perpetrated sexual abuse October 7, 2024.

**115.381 (c)** Acadiana Center for Youth at St. Martinville Pre-Audit Questionnaire response: Information related to sexual victimization or abusiveness that occurred in an institutional setting is strictly limited to medical and mental health practitioners.

Louisiana Office of Juvenile Justice PREA Manual, 6th edition, dated 2023, page 39, section XII.A.3, states any information related to sexual victimization or abusiveness that occurred in an institutional setting shall be strictly limited to medical and mental health practitioners and other staff, as necessary, to inform treatment plans and security and management decisions, including housing, bed, work, education, and program assignments, or as otherwise required by Federal, State, or local law.

Interviews with medical and mental health staff confirmed the information shared with other staff is strictly limited to informing security and management decisions, including treatment plans, housing, bed, work, education, and program assignments The auditor observed that information is securely retained by medical and mental health staff in locked file cabinets.

**115.381 (d)** Acadiana Center for Youth at St. Martinville Pre-Audit Questionnaire response: Medical and mental health practitioners obtain informed consent from residents before reporting information about prior sexual victimization that did not occur in an institutional setting unless the resident is under the age of 18.

Louisiana Office of Juvenile Justice PREA Manual, 6th edition, dated 2023, page 40, section XII.A.4, states medical and mental health practitioners shall obtain an informed consent from youth before reporting information about prior sexual victimization that did not occur in an institutional setting unless the youth is under

the age of 18.

The Mental Health Professional and RN confirmed they obtains informed consent from residents before reporting about prior sexual victimization that did not occur in an institutional setting. The process is the same for all residents, regardless of age.

**Conclusion and Corrective Action:** Based upon the review and analysis of the available evidence, the auditor has determined the facility is fully compliant with this standard regarding medical and mental health screenings; history of sexual abuse. Corrective action is complete.

**115.381 (a)** If the screening pursuant to § 115.341 indicates that a resident has experienced prior sexual victimization, whether it occurred in an institutional setting or in the community, staff shall ensure that the resident is offered a follow-up meeting with a medical or mental health practitioner within 14 days of the intake screening.

The facility provided a signed and dated plan of action detailing steps that will be taken to achieve compliance with the standard provision requirement October 7, 2024. One applicable documented follow up meeting with a mental health practitioner was provided October 7, 2024. The auditor observed the follow-up meeting occurred within 14 days of risk screening.

**115.381 (b)** If the screening pursuant to § 115.341 indicates that a resident has previously perpetrated sexual abuse, whether it occurred in an institutional setting or in the community, staff shall ensure that the resident is offered a follow-up meeting with a mental health practitioner within 14 days of the intake screening.

The facility provided a signed and dated plan of action detailing steps that will be taken to achieve compliance with the standard provision requirement. The facility provided a statement that indicated there were no residents who disclosed previously perpetrated sexual abuse October 7, 2024.

Medical and mental health staff maintain secondary materials (e.g., form, log) documenting the timeliness of emergency medical treatment and crisis intervention services that were provided; the appropriate response by non-health staff in the event health staff are not present at the time the incident is reported; and the provision of appropriate and timely information and services concerning contraception and sexually transmitted infection prophylaxis.

Louisiana Office of Juvenile Justice PREA Manual, 6th edition, dated 2023, page 40, section XII.B.1, states youth who are victims of sexual abuse shall receive timely, unimpeded access to emergency medical treatment and crisis intervention services, the nature and scope of which are determined by medical and mental health practitioners according to their professional judgment.

The Medical and Mental Health Staff stated resident victims of sexual abuse receive unimpeded access to emergency medical treatment and crisis intervention services. The nature and scope of these services would be determined according to their professional judgment and policy.

**115.382 (b)** Louisiana Office of Juvenile Justice PREA Manual, 6th edition, dated 2023, page 39, section XII.B.2, states if no qualified medical or mental health practitioners are on duty at the time a report of recent abuse is made, staff first responders shall take preliminary steps to protect the victim pursuant to Section VIII above and shall immediately notify the appropriate medical and mental health practitioners.

Staff first responders indicated they would notify medical staff.

**115.382 (c)** Acadiana Center for Youth at St. Martinville Pre-Audit Questionnaire response: Resident victims of sexual abuse while incarcerated are offered timely information about and timely access to emergency contraception and sexually transmitted infections prophylaxis, in accordance with professionally accepted standards of care, where medically appropriate.

Louisiana Office of Juvenile Justice PREA Manual, 6th edition, dated 2023, page 40, section XII.B.3, states youth victims of sexual abuse while incarcerated shall be offered timely information about, and timely access to, emergency contraception and sexually transmitted infections prophylaxis, in accordance with professionally accepted standards of care, where medically appropriate.

Medical and mental health staff confirmed victims of sexual abuse are offered timely information about access to emergency contraception and sexually transmitted infection prophylaxis.

**115.382 (d)** Acadiana Center for Youth at St. Martinville Pre-Audit Questionnaire response: Treatment services are provided to the victim without financial cost and regardless of whether the victim names the abuser or cooperates with any investigation arising out of the incident.

Louisiana Office of Juvenile Justice PREA Manual, 6th edition, dated 2023, page 40, section XII.B.4, states treatment services shall be provided to the victim without financial cost and regardless of whether the victim names the abuser or cooperates with any investigation arising out of the incident.

## Findings (by provision):

**115.383 (a)** Acadiana Center for Youth at St. Martinville Pre-Audit Questionnaire response: The facility offers medical and mental health evaluation and, as appropriate, treatment to all residents who have been victimized by sexual abuse in any prison, jail, lockup, or juvenile facility.

Louisiana Office of Juvenile Justice PREA Manual, 6th edition, dated 2023, page 40, section XII.C.1, states the facility shall offer medical and mental health evaluation and, as appropriate, treatment to all youth who have been victimized by sexual abuse regardless of where it occurred (any prison, jail, lockup, or juvenile facility).

The auditor observed medical facilities during the site review and the mental health staff reported that behavioral health care would be offered at the facility.

**115.383 (b)** Louisiana Office of Juvenile Justice PREA Manual, 6th edition, dated 2023, page 40, section XII.C.2, states the evaluation and treatment of such victims shall include, as appropriate, follow-up services, treatment plans, and when necessary, referrals for continued care following their transfer to or placement in other facilities, or their release from custody.

The medical and mental health staff interviewed confirmed evaluation and treatment of residents who have been victimized would include follow-up services. The Mental Health Professional interviewed stated evaluation and treatment of residents who have been victimized would include counseling.

**115.383 (c)** Louisiana Office of Juvenile Justice PREA Manual, 6th edition, dated 2023, page 40, section XII.C.3, states the facility shall provide such victims with medical and mental health services consistent with the community level of care.

The medical and mental health providers confirmed medical and mental health services are consistent with the community level of care.

**115.383 (d)** Acadiana Center for Youth at St. Martinville Pre-Audit Questionnaire response: Female victims of sexual abusive vaginal penetration while incarcerated are offered pregnancy tests.

Louisiana Office of Juvenile Justice PREA Manual, 6th edition, dated 2023, page 41, section XII.C.4, states youth victims of sexually abusive vaginal penetration while incarcerated shall be offered pregnancy tests.

**115.383 (e)** Acadiana Center for Youth at St. Martinville Pre-Audit Questionnaire response: If pregnancy results from sexual abuse while incarcerated, victims receive timely and comprehensive information about, and timely access to, all lawful pregnancy-related medical services.

The RN confirmed if pregnancy results from sexual abuse while incarcerated, victims are given timely information and access to all lawful pregnancy-related services.

They would be provided this information and access to services immediately.

Louisiana Office of Juvenile Justice PREA Manual, 6th edition, dated 2023, page 41, section XII.C.5, states if pregnancy results from sexually abusive vaginal penetration while incarcerated, such victims shall receive timely and comprehensive information about, and timely access to, all lawful pregnancy-related medical services.

**115.383 (f)** Acadiana Center for Youth at St. Martinville Pre-Audit Questionnaire response: Resident victims of sexual abuse while incarcerated are offered tests for sexually transmitted infections as medically appropriate.

Louisiana Office of Juvenile Justice PREA Manual, 6th edition, dated 2023, page 41, section XII.C.6, states youth victims of sexual abuse while incarcerated shall be offered tests for sexually transmitted infections as medically appropriate.

The RN confirmed victims of sexual abuse shall be offered tests for sexually transmitted infections as medically appropriate.

**115.383 (g)** Acadiana Center for Youth at St. Martinville Pre-Audit Questionnaire response: Treatment services are provided to the victim without financial cost and regardless of whether the victim names the abuser or cooperates with any investigation arising out of the incident.

Louisiana Office of Juvenile Justice PREA Manual, 6th edition, dated 2023, page 41, section XII.C.7, states treatment services shall be provided to the victim without financial cost and regardless of whether the victim names the abuser or cooperates with any investigation arising out of the incident.

Louisiana law, Act No. 229 provides that any medical treatment services provided to a resident will be at no cost to him or his family.

**115.383 (h)** Acadiana Center for Youth at St. Martinville Pre-Audit Questionnaire response: The facility attempts to conduct a mental health evaluation of all known resident-on-resident abusers within 60 days of learning of such abuse history and offers treatment when deemed appropriate by mental health practitioners.

Louisiana Office of Juvenile Justice PREA Manual, 6th edition, dated 2023, page 41, section XII.C.8, states the facility shall attempt to conduct a mental health evaluation of all known youth-on-youth abusers within 60 days of learning of such abuse history and offer treatment when deemed appropriate by mental health practitioners.

The Mental Health Professional confirmed a mental health evaluation of all known resident-on-resident abusers would be conducted within one day.

**Conclusion:** Based upon the review and analysis of the available evidence, the auditor has determined the facility is fully compliant with this standard regarding ongoing medical and mental health care for sexual abuse victims and abusers. No corrective action is required.

In the past 12 months, the number of criminal and/or administrative investigations of alleged sexual abuse completed at the facility, excluding only "unfounded" incidents: 0

Louisiana Office of Juvenile Justice PREA Manual, 6th edition, dated 2023, Page 41, section XIII.A.1, states the facility shall conduct a sexual abuse incident review at the conclusion of every sexual abuse investigation, including where the allegation has not been substantiated, unless the allegation has been determined to be unfounded pursuant to YS Policy No. A.1.4.

**115.386 (b)** Acadiana Center for Youth at St. Martinville Pre-Audit Questionnaire response:: The facility ordinarily conducts a sexual abuse incident review within 30 days of the conclusion of the criminal or administrative sexual abuse investigation.

In the past 12 months, the number of criminal and/or administrative investigations of alleged sexual abuse completed at the facility that were followed by a sexual abuse incident review within 30 days, excluding only "unfounded" incidents: 0

Louisiana Office of Juvenile Justice PREA Manual, 6th edition, dated 2023, Page 41, section XIII.A.2, states such review shall occur within 30 days of the conclusion of the investigation.

115.386 (c) Acadiana Center for Youth at St. Martinville Pre-Audit Questionnaire

response:: The sexual abuse incident review team includes upper-level management officials and allows for input from line supervisors, investigators, and medical or mental health practitioners.

Louisiana Office of Juvenile Justice PREA Manual, 6th edition, dated 2023, Page 42, section XIII.A.3, states the review team shall include the Youth Facilities Director - Statewide or their designee, PREA Compliance Manager, and upper-level management officials, with input from line supervisors, investigators, and medical or mental health practitioners.

The Facility Director confirmed the facility has a sexual abuse incident review team; the team includes upper-level management officials and allows for input from line supervisors, investigators, and medical or mental health practitioners. She confirmed the facility uses the information to make corrective actions as needed.

**115.386 (d)** Acadiana Center for Youth at St. Martinville Pre-Audit Questionnaire response: The facility prepares a report of its findings from sexual abuse incident reviews, including but not necessarily limited to determinations made pursuant to paragraphs (d)(1)-(d)(5) of this section, and any recommendations for improvement and submits such report to the facility head and PREA Compliance Manager.

Louisiana Office of Juvenile Justice PREA Manual, 6th edition, dated 2023, Page 42, section XIII.A.3, states the review team shall:

- a. Consider whether the allegation or investigation indicates a need to change policy or practice to better prevent, detect or respond to sexual abuse;
- b. Consider whether the incident or allegation was motivated by race; ethnicity; gender identity; LGBTIQ identification, status, or perceived status; gang affiliation; or was motivated or otherwise caused by other group dynamics at the facility;
- c. Examine the area in the facility where the incident allegedly occurred to assess whether physical barriers in the area may enable abuse;
- d. Assess the adequacy of staffing levels in that area during different shifts;
- e. Assess whether monitoring technology should be deployed or augmented to supplement supervision by staff; and

IS shall prepare the Sexual Abuse Critical Incident Review Form, including but not necessarily limited to determinations made pursuant to subparagraphs (4)(a)-(4)(e) of this section, and any recommendations for improvement. IS shall complete Sections A and B of the Incident Review Form and submit the completed form to the Facility Director, PREA Compliance Manager, and PREA Coordinator within 24 hours of the incident review.

The PREA Compliance Manger confirmed she is a part of the sexual abuse incident review team. The Facility Director confirmed the team considers whether the incident or allegation was motivated by race; ethnicity; gender identity; lesbian, gay, bisexual, transgender, or intersex identification, status, or perceived status; gang affiliation; or was motivated or otherwise caused by other group dynamics at the facility. The area in the facility where the incident allegedly occurred is examined to assess whether physical barriers in the area may enable abuse. Adequacy of staffing levels in the area is assessed for different shifts. She confirmed

the team assesses whether monitoring technology should be deployed or augmented to supplement supervision by staff.

The auditor reviewed the Louisiana Office of Juvenile Justice Form, C.2.11.h: PREA Sexual Abuse Critical Incident Review Form dated September 2018, and observed the form includes consideration of the factors enumerated by the standard provision.

**115.386 (e)** Acadiana Center for Youth at St. Martinville Pre-Audit Questionnaire response: The facility implements the recommendations for improvement or documents its reasons for not doing so.

Louisiana Office of Juvenile Justice PREA Manual, 6th edition, dated 2023, Page 42, section XIII.A.3, states the Facility Director and PREA Compliance Manager shall review the recommendations in the Sexual Abuse Critical Incident Review Form within 10 days of the incident review. The facility shall implement any recommendations for improvement, or shall document its reasons for not doing so in Section C of the Sexual Abuse Critical Incident Review Form. After reviewing the recommendations and making the appropriate notations in Section C, the Facility Director or designee and PREA Compliance Manager must sign the form and the PREA Compliance Manager must then forward the completed form to the PREA Coordinator and maintain a copy at the facility.

The auditor reviewed the Louisiana Office of Juvenile Justice Form, C.2.11.h: PREA Sexual Abuse Critical Incident Review Form dated September 2018, and observed the form includes a section for documenting changes implemented or the facility's reason for not implementing recommended changes.

**Conclusion:** Based upon the review and analysis of the available evidence, the auditor has determined the facility is fully compliant with this standard regarding sexual abuse incident reviews. No corrective action is required.

Louisiana Office of Juvenile Justice PREA Manual, 6th edition, dated 2023, Page 43, section XIII.B.1.b, states the Agency shall aggregate the incident-based sexual abuse data at least annually.

The auditor reviewed aggregated data from 2015 - 2023.

**115.387 (c)** Acadiana Center for Youth at St. Martinville Pre-Audit Questionnaire response: The standardized instrument includes, at a minimum, the data necessary to answer all questions from the most recent version of the Survey of Sexual Violence (SSV) conducted by the Department of Justice.

Louisiana Office of Juvenile Justice PREA Manual, 6th edition, dated 2023, Page 43, section XIII.B.1.c, states the incident-based data collected shall include the data necessary to answer all questions from the most recent version of the "Survey of Sexual Violence" conducted by the U.S. DOJ.

The auditor reviewed the Louisiana Office of Juvenile Justice Form, A.1.14 (a): Unusual Occurrence Report (UOR) dated March 2023 and observed the UOR includes the data necessary to answer all questions from the most recent version of the Survey of Sexual Violence (SSV) conducted by the Department of Justice.

**115.387 (d)** Acadiana Center for Youth at St. Martinville Pre-Audit Questionnaire response: The agency maintains, reviews, and collects data as needed from all available incident-based documents, including reports, investigation files, and sexual abuse incident reviews.

Louisiana Office of Juvenile Justice PREA Manual, 6th edition, dated 2023, Page 43, section XIII.B.1.c, states The Agency shall maintain, review, and collect data as needed from all available incident-based documents, including reports, investigation files, and sexual abuse incident reviews.

The auditor reviewed incident-based documents including investigative reports for allegations of sexual abuse and sexual harassment, UORs, and sexual abuse incident reviews team meeting reports for the 12-month audit period.

Louisiana Office of Juvenile Justice PREA Manual, 6th edition, dated 2023, Page 44, section XIII.C.1.a-c, states the Agency shall review data collected and aggregated in order to assess and improve the effectiveness of its sexual abuse prevention, detection, and response policies, practices, and training, including: identifying problem areas; taking corrective action on an ongoing basis; and preparing an annual report of its findings and corrective actions for each facility, as well as the Agency as a whole.

The auditor observed Louisiana Office of Juvenile Justice Annual Reports are published on the agency's website at: https://ojj.la.gov/policies-systems/federal-laws/prea/ojj-prea-resourcesreports/. Reports are published for 2017 through 2023. Reports include comparisons of annual data and corrective actions taken.

The Deputy Secretary, PREA Coordinator, and PREA Compliance Manager confirmed the agency reviews data collected and aggregated pursuant to § 115.387 in order to assess, and improve the effectiveness, of its sexual abuse and prevention, detection, and response policies, and training.

The Deputy Secretary confirmed the agency uses incident-based sexual abuse data to assess and improve sexual abuse prevention, detection, response policies, practices, and training. When deficiencies are identified, corrective action is taken.

The PREA Coordinator stated during monthly meetings held with the heads of each department, the Facility Director and PREA Compliance Manager discuss prevention, detection, response, any additional training, and areas of noncompliance. All data collected is placed in locked file cabinets and/or in the Investigative Services Data Base and PREA Database. Any request by outside sources for information must be made through the Louisiana Office of Juvenile Justice legal department and identifying information redacted prior to release. Corrective action is taken on an ongoing basis based on the data. The agency prepares an annual report of its findings from its data review and any corrective actions for each facility, as well as the agency as a whole.

The PREA Compliance Manager confirmed the agency reviews data collected and aggregated pursuant to 115.387 in order to assess and improve the effectiveness of its sexual abuse prevention, detection, and response policies and training. The role the facility plays in the review is gathering data and making a comparison to other years. Corrective actions are reviewed and if needed policies are changed to adapt to PREA standards.

**115.388 (b)** Acadiana Center for Youth at St. Martinville Pre-Audit Questionnaire response: The annual report includes a comparison of the current year's data and corrective actions with those from prior years. The annual report provides an assessment of the agency's progress in addressing sexual abuse.

Louisiana Office of Juvenile Justice PREA Manual, 6th edition, dated 2023, Page 44, section XIII.C.2, states such report shall include a comparison of the current year's data and corrective actions with those from prior years and shall provide an assessment of the Agency's progress in addressing sexual abuse.

The auditor reviewed the Louisiana Office of Juvenile Justice 2023 Annual PREA Report and determined the report is inclusive of the standard provision requirements. Tables and charts easily show the reader a comparison of the current year's data and corrective actions to those from 2021 and 2022.

**115.388 (c)** Acadiana Center for Youth at St. Martinville Pre-Audit Questionnaire response: The agency makes its annual report readily available to the public at least annually through its website. The annual reports are approved by the agency head.

Louisiana Office of Juvenile Justice PREA Manual, 6th edition, dated 2023, Page 45, section XIII.C.3, states the Agency's report shall be approved by the Deputy Secretary and made readily available to the public through the Office of Juvenile Justice (OJJ) website at http://www.ojj.la.gov/.

The auditor observed the published Louisiana Office of Juvenile Justice 2023 Annual PREA Report at: https://ojj.la.gov/page/resources-reports. The report is approved by the Louisiana Office of Juvenile Justice Deputy Secretary.

**115.388 (d)** Acadiana Center for Youth at St. Martinville Pre-Audit Questionnaire response: When the agency redacts material from an annual report for publication the redactions are limited to specific materials where publication would present a clear and specific threat to the safety and security of the facility. The agency indicates the nature of material redacted.

Louisiana Office of Juvenile Justice PREA Manual, 6th edition, dated 2023, Page 45, section XIII.C.4, states the Agency may redact specific material from the reports when publication would present a clear and specific threat to the safety and security of a facility but must indicate the nature of the material redacted.

The auditor reviewed the Louisiana Office of Juvenile Justice 2023 Annual PREA Report and observed no identifying information. The report indicates the nature of material redacted.

The PREA Coordinator confirmed the agency ensures that data collected pursuant to § 115.387 are securely retained. All data collected is placed in locked file cabinets and/or in the Investigative Services Data Base and PREA Database. Any request by outside sources for information must be made through the Louisiana Office of Juvenile Justice legal department and identifying information redacted prior to release.

The auditor observed the investigation files are retained electronically with Investigative Services (IS).

**115.389 (b)** Acadiana Center for Youth at St. Martinville Pre-Audit Questionnaire response: Agency policy requires that aggregated sexual abuse data from facilities

under its direct control and private facilities with which it contracts be made readily available to the public, at least annually, through its website.

Louisiana Office of Juvenile Justice PREA Manual, 6th edition, dated 2023, Page 45, section XIII.D.2, states after removal of personal identifiers, the Agency shall make all aggregated sexual abuse data from facilities under its direct control and private facilities with which it contracts, readily available to the public at least annually through its OJJ website.

The auditor reviewed the Louisiana Office of Juvenile Justice 2023 Annual PREA Report published on the agency website at https://ojj.la.gov/page/resources-reports.

**115.389 (c)** Acadiana Center for Youth at St. Martinville Pre-Audit Questionnaire response: Before making aggregated sexual abuse data publicly available, the agency removes all personal identifiers.

Louisiana Office of Juvenile Justice PREA Manual, 6th edition, dated 2023, Page 45, section XIII.D.2, states after removal of personal identifiers, the Agency shall make all aggregated sexual abuse data from facilities under its direct control and private facilities with which it contracts, readily available to the public at least annually through its OJJ website.

The auditor reviewed the published Louisiana Office of Juvenile Justice 2023 Annual PREA Report and observed personal identifiers were not included in the reports.

**115.389 (d)** Acadiana Center for Youth at St. Martinville Pre-Audit Questionnaire response: The agency maintains sexual abuse data sexual abuse data collected pursuant to §115.387 for at least 10 years after the date of initial collection, unless Federal, State, or local law requires otherwise.

Louisiana Office of Juvenile Justice PREA Manual, 6th edition, dated 2023, Page 45, section XIII.D.3, states the Agency shall maintain sexual abuse data collected pursuant to Section XIII.B of this Section for at least ten (10) years after the date of its initial collection unless Federal, State, or local law requires otherwise.

The auditor reviewed historical sexual abuse data from 2015 through 2023.

**Conclusion:** Based upon the review and analysis of the available evidence, the auditor has determined the facility is fully compliant with this standard regarding data storage, publication, and destruction. No corrective action is required.

**Findings:** During the three-year period starting on August 20, 2013, and the current audit cycle, the Louisiana Office of Juvenile Justice ensured that each facility operated by the agency, or by a private organization on behalf of the agency, was audited at least once. Also, one-third of each facility type operated by the agency, or by a private organization on behalf of the agency, was audited. This is the first PREA facility audit for Acadiana Center for Youth at St. Martinville. The facility opened in September 2023.

The auditor was given access to, and the ability to observe, all areas of the Acadiana Center for Youth at St. Martinville. The auditor was permitted to conduct private interviews with residents at the facility. The auditor sent an audit notice to the facility more than six weeks prior to the on-site audit. The facility confirmed the audit notice was posted by emailing pictures of the posted audit notices. The audit notice contained contact information for the auditor. The residents were permitted to send confidential information or correspondence to the auditor in the same manner as if they were communicating with legal counsel. No confidential information or correspondence was received.

**Conclusion:** Based upon the review and analysis of the available evidence, the auditor has determined the agency and facility is fully compliant with this standard regarding frequency and scope of audits. No corrective action is required.
